PASTOR'S ANNUAL REPORT

The steadfast love of the LORD never ceases, his mercies never come to an end; they are new every morning; great is your faithfulness. (Lamentations 3:22-23 NRSV)

It is with a profound sense of gratitude that I look back at 2007, a very busy and challenging year. Our church family has progressed and grown in many areas these past twelve months. Statistically, we have increased to more than four hundred members. Financially, rather than a deficit, we ended the year with surplus enough to replenish our cash reserves and pay off our Phase I debt to the bank. I love the fact that we have had so many more baptisms and weddings this year, though our congregation has also faced some very difficult and painful losses. As you read the various ministry reports, you will notice an increase in our programming with more people participating in them. Isn't it wonderful that attendance at our worship services has also increased and that our choir has grown significantly this past year.

Beyond this particular congregation, I continue to serve on the board of directors and moderate the Quality Assurance Committee at the Mesilla Valley Hospice. In January, encouraged by the Session, I began my D.Min. studies at Louisville Theological Seminary, which will focus on church leadership and improving my skills as your pastor. My service to the Presbytery of Sierra Blanca includes moderating the Finance and Administration Committee, serving on Presbytery Council, serving on the Transition Task Force, and I moderate the commission formed to resolve the financial and management problems at Camp Chimney Spring.

The major highlight of this year for me was the amazing work that went into our church hosting the Presbytery of Sierra Blanca and the Presbytery of Santa Fe in a joint presbytery meeting, which included a visit from Rev. Joan Gray, moderator of the Presbyterian Church (USA). Our Session, our deacons and our members have worked hard and faithfully this year, and the health of our church is good and growing. God has blessed us abundantly this year and entrusted us with more opportunities to reach out to our community and to this world with God's truth, love, compassion and mercy.

Our challenge is to consider and reflect upon our faithfulness to the vows and promises that were made when we joined this church and whenever we baptize. God's love is so evident and so present among us in this church. Indeed, look around for how abundantly we have been blessed and challenged this past year. God's faithfulness is never in question. Really, the question is, how will we choose to respond to the Lord's love, call and purpose on into the future? In Jeremiah 29:11, God's makes a promise most appropriate for us to hear and consider this today, "For surely I know the plans I have for you, says the LORD, plans for your welfare and not for harm, to give you a future with hope."

The Board of Deacons serves the congregation and the community in many ways. These services include:

- * <u>Ushering</u>. Greeting our worshipers, handing out the service program and collecting the offering
- * Transportation. Helping our church families to attend services
- * <u>Transient meals</u>. Providing sack lunches to transients
- * <u>Visitations</u>. Visiting our home bound and hospitalized church family members.
- * <u>Soup Kitchen</u>. Sets up teams of workers for the local soup kitchen
- * <u>Special Events</u>. Coordinates events such as the annual Deacon Hamburger Fry, Hospice food baskets, and the Socks and Undies drive for needy children, etc.

Each Deacon is assigned to one of the six Deacon Committees above and one of the six Session Teams as well. Additionally the Deacon Moderator attends the Session meetings to provide communication between the two Boards.

The Deacons have furnished financial assistance to members of our congregation and local needy families of the community in cases of special need. This supplied support and emergency assistance has been provided in the form of sack lunches, gas vouchers, bus tickets, purchase of car tires, medical bill payments, rent assistance, food baskets, underwear, blankets, gift certificates and inspirational materials. However, the above mentioned activities of the Board of Deacons are generously financed by you, the congregation. Our funds are generated by our annual hamburger fry, one-half of the loose offerings and the monthly communion offerings. Additionally, your generosity helped us provide twelve Christmas food baskets (each weighing over 75 lbs each) for needy hospice and church families. Through your generosity, your Board of Deacons is able to make a positive contribution and lasting impact to our surrounding community as well as to our own community of believers. Thanks be to God!

Ministry Team: ADMINISTRATION

The Administration Ministry Team is responsible for the administration of church policy, personnel matters, financial matters, supplies, and equipment, from the vans to the communications and technical devices. Mel Parish, Dina Schroeder, and Mary Kammann were elders on the team. Lynn Lawson-Jones and Winnie Quinzi were the deacons on the team.

The Policies and Procedures document was reviewed and modified in the areas of money handling, wedding procedures, and in the clarification of vacation time accrual. The money handling procedures were modified to reduce any appearance of possible mishandling of donated funds.

The admin team spent considerable effort during the year trying to improve the process for performance evaluations. The evaluation forms were tailored to each job description and implemented in electronic format to allow each evaluator to edit each form if desired. In addition, the evaluations are discussed in face-to-face meetings with employee and the supervisors. After two evaluation cycles in 2007 the process seems to be getting better as evaluators get used to the new method. Two personnel actions occurred during the year: (1) a Youth Director was hired, and (2) a Youth Intern was hired.

A volunteer was recruited to serve as church treasurer with the duties expanded somewhat from previous years. Unfortunately, family and school schedules proved to be too difficult to work around, and the volunteer was not able to continue. That position remains to be filled for 2008. Volunteers are still welcome.

The generous giving of the congregation included \$496,826 toward operating income plus another \$265,170 toward designated projects. A donation from the estate of Don Rubart allowed the Phase I Debt to the bank to be paid in full. The remaining debt to sixteen families of the congregation has now been reduced to \$135,000 and we encourage the congregation to contribute to the complete payment of this remaining debt. The reductions in personnel, cuts in our budget, and the faithful stewardship of the congregation made the financial situation for 2007 much more favorable than in 2006. We ended the year 2007 with \$68,243 in operating funds and \$90,880 in reserves. Included in that balance are funds from the sale of the Christian Day Nursery (\$63,880) and an endowment from Don Rubart (\$21,290). With increased costs of maintenance, utilities, and expanding programs an increase in the 2008 budget to \$546,000 was necessary. The session will be monitoring our cash flow closely to maintain stable operation.

As a result of action taken by the session in 2007, funds budgeted but not spent in 2007 for Capital Improvements and for Organ Maintenance will be carried forward to 2008. The action for Capital Improvements is planned to continue as a method of hedging against large capital expenditures in the future.

For 2007, 231 contributors gave \$455,567 compared to 227 donors of \$427,385 in 2006. For 2008, there are 105 pledges for \$317,000 compared to 114 pledges of about \$360,000 in 2007.

We give thanks to our congregation for giving, volunteering, and supporting our mission and ministry. We also give special thanks to Blaine Goss, the Missions Ministry Team, Gary Gemoets of Deacons, Matt Holt, Dena Schroeder, and Susan Grandle for providing Minutes for Mission during our fall stewardship campaign.

Accomplishments for the year 2007 have included:

West choir room door repaired. Door closer was replaced.

Kneeling benches repaired.

Gate locks on the east side repaired, one replaced.

Reflective driveway markers placed and replaced...

Major plumbing rework on the east side of the sanctuary was completed, consisting of replacing much of the underground piping at considerable cost.

Replaced the ice machine in Reeves hall kitchen.

A work day was scheduled and many small items dealt with. A major project in the garage was initiated to build shelves for more efficient storage there. It is about half completed.

The faucet set in Reeves kitchen was replaced.

The garage door opener was repaired.

A new basketball court was striped and equipped with permanent goals set in concrete. Randy Farmer had this done and also repainted all parking area striping.

Numerous "leaks and squeaks" were noted on work orders and some were dealt with.

Ministry Team: CHRISTIAN EDUCATION

The educational programs of First Presbyterian range from birth to adult and from Sunday School to midweek programs. We celebrate the following successes:

- Our team established goals to develop a 3 year cycle of core classes for preschool through adults to include biblical understanding, catechism, moral and social issues, and global awareness; re-think Sunday School; and teacher training and recruitment.
- Beverly Briggs concluded her successful three year tenure as the Sunday School Superintendent in December 2007. She reports that Sunday School attendance was at year high in September, with 99 attending a variety of classes.
- The video based Sunday School class for adults continues to be very successful. We were please with the warm reception and high attendance the class on Islam received.
- A thriving Bible book-based class facilitated by Dick Dale continues to meet each Sunday morning.
- Two new adult study groups have been formed; one for men and one for women.
- Topical studies, such as Advent, are available for small groups.
- Elementary Sunday School Classes which have enjoyed using PCUSA's We Believe curriculum taught by a variety of teachers.
- Well run Sunday School preschool classes with very able teachers Judith Ames and Carol Goss.
- The hiring of Travis Becker as Youth Director, who has jumped in and is dedicated to furthering the faith development of the young people in our church and community.
- A very successful high school mission trip building a home in Juarez with Casas por Cristos. 12 youth and 5 adults along with the generous contributions of our congregation made a new home a reality for one very grateful family.
- Middle school students were able to attend The Great Escape in Gunnison, Colorado which was hosted by Presbyterians for Renewal. It was a very powerful and meaningful opportunity for those young people to develop their faith. This would not have been possible, except for the dedication and commitment of Randy and Cindy Farmer and their super chaperones: Greg and Kelly Temple and Travis Becker.
- The hiring of a student intern, Scott Burns, for the summer of 2007 was so successful that his contract has been extended. He has played a vital role in our ministry to The Children's Garden, the child care tenant who occupies Branigan Hall. His other contributions are too numerous to mention.
- Church School classes, which run for preschool through elementary aged students, are available during the worship time after the Young Disciples Talk.

- Vacation Bible School which brought 90 kids to our church, many who came from The Children's Garden and the community.
- A new summer outreach in the form of Bell Camp. Lois Cook, Scotty Burns, and members of the Bell Choir led a group of 14 students.
- Salt and Light, the midweek ministry, continues to be an important part of what Christian Education is all about.
- A midweek class that is led by Rev. Norm Story on how to study the Bible.
- A partnership with Iglesia del Pueblo, the Hispanic congregation which meets in our church has been formed. During their worship, the children of that congregation attend our Sunday School classes. Iglesia del Pueblo also has been involved with Salt and Light.

The ministry of this team is accomplished through the dedication of the above mentioned individuals as well as over 80 volunteers who have worked diligently to further the educational programs for the community and our congregation. Mission Ministry Team Actions:

The Committee completed a DVD about the Mission program of our church. It featured the Trudells, who work for Wycliffe and SIL in Africa, and the Haspels, who work with two isolated tribes in Ethiopia. We showed this DVD at the annual congregational meeting in February 2007. The DVD is also available for any other church use. The team maintains close contact with all the mission programs we support and attempts to keep the congregation informed about these various programs -- via articles in "The Lantern" and "Good News", our "minutes for mission" oral presentations, the Missionary Bulletin Board and by participation in the Vacation Bible School. We also began putting a different missionary each week on the prayer list.

A very visible educational activity is the sponsoring of visits by missionaries to the church. During 2007, we had two such visits. In February, Don Lytton briefed the Committee on the Lyttons' activities in China. In May, Don and Kim met with the Committee and other interested members of the congregation at the home of Beverly Briggs.

Our budget for 2008 reflects a slight overall increase from 2007 to a total of \$52,500, which is still less than our 2006 budget. We terminated our support of Camp Chimney Springs and of Ricardo and Reyna Green, who returned to the U.S. from Brazil. Our 2008 budget reflects our decision to increase funding levels of missionaries whom we already support, rather than to begin funding any new activities. We did so because we had not increased support to our missionaries for the past several years, despite increased costs and inflation.

Our planned missionary trip to Sheldon Jackson College in Alaska fell through at the last moment due to a sharp increase in cost of the airfare. Moreover, the college subsequently suspended its operations indefinitely. Its future is questionable.

Tommy Matkin replaced Bob Taylor as our church's representative on the Board of Directors of Cristo Rey Outreach in Sunland Park.

Barney Rawson, a longtime stalwart of our church, died suddenly in June. Blaine Goss stepped up and completed Barney's term on our team. We are thankful for Barney's many years of service and for Blaine's willingness to join our Committee on short notice.

Missions Work by Congregation Members:

support to other mission programs of special interest to them.

Our congregation does much mission work in addition to the programs which our Committee directly supervises. Church youth made a mission trip to Juarez, Mexico, during the year. The Deacons organized and coordinated our church's support to the Gospel Rescue Mission and Mesilla Valley Hospice. Presbyterian Women emphasized giving to a different program each month. PURPOSE

Forgiven and freed by God in Jesus Christ, and empowered by the Holy Spirit, we commit ourselves:

To nurture our faith through prayer and Bible study, to support the mission of the church worldwide, to work for justice and peace, and to build an inclusive, caring community of women that strengthens the Presbyterian Church (USA) and witnesses to the promise of God's kingdom.

In 2007, our local Presbyterian Women (PW) met its obligation to the purpose in the following ways:

SCOUT COMMITTEE REPORT

The purpose of Boy Scouts of America is to help youth become honorable adults through the three aims of Scouting: Building character; Fostering citizenship; and Developing mental, Moral and physical fitness.

Building character: This past fall we had a young boy in his second year of Webelos (a den of 10-11 year olds) who had finished his Arrow of Light requirements and was ready to become a member of the Scout Troop. His advancement was announced at a party we had just before breaking for the Christmas holidays. He asked if he could say something so we got the room full of young partygoers to quiet down. In a brief but moving speech he thanked the leaders for their help toward his advancement then he raised his cup and proposed a toast to Troop 62. That, friends, is building character.

Fostering citizenship: Every week's meeting is opened with a flag ceremony and pledge of allegiance. This opening is for both Cub Scouts and Boy Scouts with one of the Boy Scouts in charge. He usually picks boys from both the Pack and the Troop. In this way they are seen as parts of the whole and the basis of citizenship is reinforced.

Developing mental, moral and physical fitness: We have a strong camping program for our Scouts. During the summer of 2007 about seven Boy Scouts attended summer camp for a week. In that week they completed a total of 21 merit badges. One Scout who was unable to attend summer camp with the others demonstrated initiative by completing 12 merit badges on his own.

Paraphrasing the speech referred to above, Thanks to all of you who make this program possible. Here's to First Presbyterian Church Scouting Program.

FIRST PRESBYTERIAN CHURCH OF LAS CRUCES FOUNDATION, INC.

Our local church Foundation is a tax-exempt corporation, which was established to provide long-term financial support for the Church, while allowing members to take advantage of the tax benefits that are possible through donations to the Foundation. The Foundation can accept gifs of marketable securities (stocks, bonds, etc.), real estate or other appreciated property with significant tax advantages to the donor over just straight cash donations.

The Board manages the funds donated to the Foundation and the eventual expenditure of any of these funds to continue to reflect the wishes of the original donors. The church financial secretary keeps a record of the designated gifts in the Foundation.

The Foundation has also been asked by Session to manage the loan accounts set up by some members of the congregation. These funds were loaned by individuals to pay down the church renovation loan and issue what is referred to as CDs (really signature loans) at current variable CD rates adjusted every six months. Current rates are 5% with a guarantee not to go below the initial rate of 4.3%. At this time members of our congregation are providing \$135,000 to the church for this effort.

Foundation funds are invested with the Vanguard Long-Term Investment-Grade Fund. As of December 31, 2007, the fund had a balance of \$41,142.76 In addition to these funds the Foundation has a balance of \$21,124 in cash and some real estate. It has two donated lots in Deming (small value) and a house in Las Cruces. The house is rented and is providing a monthly income. All property is free and clear. The foundation has been the beneficiary of estates in the past but was not a beneficiary in 2007.

The membership of the Board of Directors in 2007 consisted of Arlyn Kriegel, Steve Loman, Robert McPherson, Kate Puckett, Bobby Rankin, Gerald Thomas and Jim Parks.
