PASTOR'S INTRODUCTION TO THE ANNUAL REPORT OF 2008

"The steadfast love of the LORD never ceases, his mercies never come to an end; they are new every morning; great is your faithfulness."

(Lamentations 3:22-23)

God is always faithful. Our God has remained steadfast and present throughout this most extraordinarily challenging year in our life together as a Presbyterian congregation. Once again, the necrology report includes the familiar names of dear friends of our church family, all of whom we miss terribly. We have been blessed this year with many more weddings and baptisms, and wonderful new members have joined us, but our losses still hurt.

The Elders serving on the Session in 2008 faced some very difficult decisions, including changes in personnel for which the details necessarily had to be held in confidence. Our dedicated Elders served with strength, faithfulness, and unity. It was an unexpectedly complicated process to figure out certain office and financial functions, to update and improve procedures, and adjust to new personnel. Church members have felt frustrated at times when their questions and concerns could not be answered as they had in the past. Office staff and members of the Administration Ministry Team in particular have worked tirelessly and diligently through problems and difficulties far more complex than anyone could have anticipated. We are pleased that the work is coming together.

Another welcome bright spot is that our financial giving did increase during 2008, and ended well above our expenses. Though our financial pledges for this coming year are down slightly, we expect that our current levels of giving will cover our expenses, despite the turmoil and uncertainty of our national economy. The Session will be monitoring income and expenditures very carefully this year. Our church is in good financial health and contributions are being spent as their donors intended.

The various ministries, organizations, and programs of our church have also done very well this year. The accomplishments of our Deacons are noteworthy. Through the Deacons' ministries of compassion, Presbyterian Women and many others, our church has made a real difference in our community and in the world, as reflected in this annual report. Your church staff has consistently worked hard as a strong team, and they have tackled new tasks with imagination, willingness to learn, and cooperation. All of those who so generously volunteer their time and talents, who continue to serve so faithfully, are nothing short of wonderful and amazing. It is by the faithful efforts of our whole church family, serving for the glory of God, that this congregation can function and fulfill our mission. Thank you, everyone. Thank you all who serve with such love and commitment.

As you read this report and hear from the moderators of our ministries, you will be pleased by how much they have each accomplished and how God has provided resources and opportunities far beyond our expectations. This year, be encouraged to look for those places where you have an interest, where you can bring your ideas, where you can serve. We are not called and saved by Christ just to sit back, watch, and do nothing. Scripture assures us that all are specifically equipped to serve God in some way. We rebel against God's will and intention if we are not involved in the church's mission. All of our church's ministries and programs are looking for people who are willing to help and make a difference, for as Jesus said to his disciples, "The harvest is plentiful, but the laborers are few; therefore ask the Lord of the harvest to send out laborers into his harvest." (Matthew 9:37-38)

Looking ahead, at the Elders' retreat a few weeks ago we focused on two general areas where we hope for significant improvement this coming year. First, we want to do better at inviting and helping each visitor and member recognize and bring their particular interests and gifts for ministry, and to participate in meaningful ways, in this church's mission by becoming actively serving faithful members. Second, we want to communicate better with the whole congregation by ensuring that information and answers to questions are always readily available. You can find all of the minutes from every ministry team, including the Session now posted on the bulletin board in Jones Hall. In addition, you can read or download them from our church website. Members are encouraged to read them, ask questions, make comments, offer suggestions, and become more involved.

Finally, there are some new faces on our church staff. You will hear more from Mark Hellman our youth specialist and director, during the youth report. We can expect great things through his ministry. Michelle Del Rio is our new bookkeeper. She is working part-time; therefore, during the morning on weekdays is the best time to call with any questions regarding finance or your contributions. The college intern position is being job-shared by Shannon Kilburg and Courtney Prahl; both are sophomore students at NMSU.

I believe that we are poised for a wonderful and exciting year ahead. Our God is always faithful, so really the question is, how will we choose to respond to the Lord's love, God's call, and our church's mission on into the future? In Jeremiah 29:11, God makes a promise most appropriate for us to hear and consider today, "For surely I know the plans I have for you, says the LORD, plans for your welfare and not for harm, to give you a future with hope."

The Administration Ministry Team would like to thank Lyn Ames for serving as our church Treasurer and reviewing 2006 and 2007 church transactions. We gladly implemented a few recommended suggestions.

We would also like to thank Barbara Kewley for chairing our Stewardship campaign for 2008. It was a successful campaign. For 2009 we received <u>110</u> pledges totaling <u>\$316,596.64</u> compared to 2008 we received <u>116</u> pledges totaling <u>\$328,683.16</u>.

Mid-year and end of year evaluations were completed on time. We were able to issue an end of year bonus to our faithful staff. We had several personnel action items in 2008 (1) hiring of a payroll clerk (2) hiring of a bookkeeper (3) hiring of a Youth Director and (4) a Youth Intern was hired.

Our Church's incorporation status was re-instated thanks to Carl Connor's diligent persistence. Thank you Carl!

Much needed computer software and hardware upgrades were completed and are in the process of being completed. Thank you to David Yaryan for volunteering his computer knowledge in helping make these upgrade decisions.

We began the revision of our Church's Employee Policy and Procedure manual. The Administration Ministry Team will continue this process in 2009.

A heartfelt thank you to the entire committee for their support and input with all Administration matters this past year.

Ministry Team: BUILDINGS AND GROUNDS

- Installed a flow meter on the irrigation pump. Uncovered and repaired the distribution PVC from the pump. Flushed the sprinkler system to get a proper distribution. Replaced several sprinkler heads in the lawn irrigation system.
- Provided a home and support for the work of the columbarium committee.
- The water heater in Jones hall was replaced to eliminate the bad smell coming for the hot water. Because this proved only a temporary fix, it was replaced by an on-demand water heater. This heater is also more economical in addition to eliminating the odor. The old water heater is less than a year old and will be sold. The sink area in the kitchen was refurbished with a double sink and a disposal unit.
- A number of light bulbs and fluorescent tubes were replaced in Jones hall and Two of the ceiling spotlight lamps were replaced and several were redirected. Bulbs in the large circular lamps over the choir were replaced. Several outside lights on photocells were replaced as well as two new lenses. Overhead lights in Narthex replaced. The bulbs in the lamps over the kitchen stove were replaced. The kitchen ovens were recalibrated.
- Considerable work was done in the playground Area. Fence repairs were made. The ground cover (weed control cloth) was replaced under the swings and slides and the surface leveled with wood chips. Our Scout Troop helped with this project. Broken play structures were removed and discarded. The picnic table was rebuilt when the 300 lb. concrete top collapsed and fell onto the concrete benches.
- Bumpers were placed under the refrigerators and freezer units in Watkins Hall kitchen to allow "breathing space" between the walls and the appliances.
- Remounted the doorstop, entrance to Reeves Hall and realigned the emergency doors on the west side. Remounted doorbell button, Jones Hall.
- Refrigerator in Watkins was repaired when it quit cooling.
- The light control console in the Deacons room was repaired.
- A number of repairs and service calls were required for the kitchen dishwashing station and the dishwasher. The hose and nozzle for the rinse were replaced. The large-objects filter screen disintegrated as a result of corrosion and use and was replaced.
- The gate lock mechanism next the sanctuary entrance was repaired. The gate latch on the SE corner of the Children's Garden (Branigan Hall). The playground gate at the east end of Jones Hall was re-anchored with heavier hardware.
- The lock on the door at the East End of Reeves hall was modified to end the illegal tampering that prevented securing the building properly.
- The doorbell in Watkins Hall was disabled because it was disrupting the SAT tests being taken by High school students. After coordination with the Children's Garden, owners of the system, it was decided that the system, in Watkins only, would be left inoperative.

- A Workday was held in May; Seven new handicapped parking signs replaced old deteriorated signs. Completed the shelving project in the garage. Also inspected and inventoried all folding chairs and condition of same at the request of Administration Ministry Team.
- Wooden fences around ac/units of Jones and Reeves Halls were painted.
- Removed the littered bricks around the north area of the campus and inventoried and stacked them for use in the columbarium. Work performed by the columbarium committee.
- Removed the Styrofoam "mountain" in Watkins hallway and patched the resulting holes.
- Refurbished 10 of the pew candle holders used on Christmas Eve.
- Planned, designed and installed the sign identifying our church as the home of La Iglesia del Pueblo, our Hispanic congregation.
- Revised the B&G work order form.
- Several repairs were made to the west garage door opener. It is now operational.
- Job descriptions were drafted for two positions; Sunday sexton and staff support. Brian McPherson and Michael McClanahan have previously performed the work with Michael currently filling both jobs.

The accomplishments of Buildings and Grounds team would not have been possible without major contributions from other ministry teams and members and friends of the church.

On June 7, we held a workday. A Workday was also completed October 8, The Breck family- Austin, Gena and young disciples Kyle and Rachel, all pitched in. Also giving a big assist were Ed and Donna Mathis, Nora and Charlie Yaryan, Lyn and Judith Ames, Tommy and Dutch Matkin, Bill Diener, Bruce Pearson, Mel Parish, Brian McPherson, and Mike McClanahan. One of the highlights of the Mission Ministry Team is our visiting missionaries from around the world. In 2008 we had visits from:

- 1) John Haspels filled the pulpit on January 13, 2008, and made an after-worship presentation about his mission in Ethiopia.
- 2) Doug Barron, visiting on January 20, gave the minute for mission during worship and presented a program after worship explaining mission work done by him and his wife Sherrie through Campus Crusade for Christ.
- 3) Ron & Donna Pontier and their daughter Brianna visited on July 20. Ron filled the pulpit and made a presentation explaining their work in Central African Republic with AIM/AIR. Donna arranged a display of Africanmade articles to enhance Ron's presentation.
- 4) Don & Kim Lytton were with us in August. Kim shared her musical talents during worship and Don visited with the Mission Ministry Team.

A mission team of adults from St. Andrew's Presbyterian Church, Albuquerque, working on a water project for Mesquite, NM, were welcomed and housed by members of our congregation during their time in our area.

Ann Blakely, of our congregation, and Judy Kemper, of Sonoma Ranch Presbyterian Church, made an after-worship presentation on September 28 sponsored by the Mission Ministry Team. Their presentation was on a Synod-sponsored mission program "Beyond Our Borders" which is a focus on immigration. Ms Julia Thorn, PCUSA Immigration attorney, did a minute for mission during worship and an after-church presentation in conjunction with the other two ladies.

Each member of the mission team corresponds with three to four of our missionaries in the field to stay informed of their needs and activities. This fulfilled our #1 goal for 2008: to keep the congregation informed of mission activities. Another goal set for 2008 was to update our Missions Directory; articles were gathered in November and the directory will be published in early 2009. Our other goal was to work with Salt & Light and Vacation Bible School when asked.

The Mission Ministry Team sponsors four special offerings for the General Assembly of the PCUSA. They are: One Great Hour of Sharing, Pentecost Offering, Peacemaking Offering, Joy Offering. Our portion from the Pentecost Offering (\$652) was given to our Spanish congregation; our share of the Peacemaking Offering (\$161) was given to La Casa of the Cristo Rey Border Ministry.

The Proposed Mission Budget for 2009 is \$50,875, which reflects a 5% increase for our missionaries. The loss of two missionaries during 2008 allowed this increase. We appreciate the generosity of our church family to the mission program.

PRESBYTERIAN WOMEN

Presbyterian Women in the congregation of First Presbyterian Church Las Cruces, is organized with the consent of Session as an independent organization within the church with its own leadership, program and budget. Overall planning for the year is provided by a Coordinating team composed of a moderator, Janet McPherson; treasurer, Ruth Ford; secretary, Evelyn Horst; coordinators of mission programs, and a representative from each Circle and Guild.

Presbyterian women in the Congregation is a member of the Presbyterian Women in the Presbytery of Sierra Blanca and the Presbyterian Women of the Synod of the Southwest.

PURPOSE

Forgiven and freed by God in Jesus Christ, and empowered by the Holy Spirit, we commit ourselves:

To nurture our faith through prayer and Bible study, to support the mission of the church worldwide, to work for justice and peace, and to build an inclusive, caring community of women that strengthens the Presbyterian Church (USA) and witnesses to the promise of God's kingdom.

Presbyterian women are organized into circles which meet monthly from September thru may for worship, study, and fellowship. Circles select their own study subjects, and select their own leaders.

Local missions supported by Presbyterian women include: the Bridge (NMSU Campus Ministries), Jardine de los Niños, La Casa, La Casita, Casa de Peregrinos, St. Luke's Health Clinic, the Gospel Rescue Mission and the Community of Hope. Monetary contributions are received by circles, gifts in kind are placed in a box in Jones Hall and distributed to designated recipients. We also support the work of Church Women United of Las Cruces. We participate in national missions through "Together in Service" (missions to overseas projects), the Birthday Offering, the Thank Offering, and the Offering of the Least Coin.

During 2008, PW helped sponsor two participants in a women's conference held in El Paso and Juarez concerning immigration problems called "Beyond Borders". Judy Kemper and Ann Blakely have presented information and a slide show concerning this conference to Presbyterian women and to the congregation.

The Memorial Student Aid Fund is administered by a committee of Presbyterian Women. College students of our congregation receive scholarship support from dividends of the investment in the New Covenant Fund. The fund receives memorial donations, which are added to the principal, only the dividends are used to fund the scholarships.

Memorial Student Aid Fund

This first manse for First Presbyterian Church was built by funds raised by the Ladies Aid Society about 1935. Eventually that manse was sold and the \$2000.00 received was turned over to the College Circle. In 1969 the *Memorial Student Aid Fund* was established with the provision that the principal would remain intact and only the interest would be used for college scholarship aid. Through the years the principal has increased through memorial donations and funds transferred from Presbyterian Women. Scholarships from the Memorial Student Aid Fund have been awarded to over 100 students since the fund was established in 1969.

FIRST PRESBYTERIAN CHURCH OF LAS CRUCES FOUNDATION, INC.

Our local church Foundation is a tax-exempt corporation, which was established to provide long-term financial support for the Church, while allowing members to take advantage of the tax benefits that are possible through donations to the Foundation. The Foundation can accept gifs of marketable securities (stocks, bonds, etc.), real estate or other appreciated property with significant tax advantages to the donor over just straight cash donations.

The Board manages the funds donated to the Foundation and the eventual expenditure of any of these funds to continue to reflect the wishes of the original donors. The church financial secretary keeps a record of the designated gifts in the Foundation.

The Foundation has also been asked by Session to manage the loan accounts set up by some members of the congregation. These funds, were loaned by individuals to pay down the church renovation loan and issue what is referred to as CDs (really signature loans) at current variable CD rates adjusted every six months. Current rates are 5% with a guarantee not to go below the initial rate of 4.3%. At this time members of our congregation are providing \$105,000 to the church for this effort.

Foundation funds are invested with the Vanguard Long-Term Investment-Grade Fund. In addition to these funds the Foundation has some real estate. It has two donated lots in Deming (small value) and a house in Las Cruces. The house is rented and is providing a monthly income. All property is free and clear. The foundation has been the beneficiary of estates in the past and welcomes additional donations at any time.

The membership of the Board of Directors in 2008 consisted of Arlyn Kriegel, Steve Loman, Robert McPherson, Kate Puckett, Bobby Rankin, Gerald Thomas and Jim Parks.
