PASTOR'S INTRODUCTION TO THE ANNUAL REPORT OF 2010

Grace to you and peace from God our Father and the Lord Jesus Christ. I give thanks to my God always for you because of the grace of God that has been given you in Christ Jesus, for in every way you have been enriched in him, in speech and knowledge of every kind— just as the testimony of Christ has been strengthened among you— so that you are not lacking in any spiritual gift as you wait for the revealing of our Lord Jesus Christ. (1 Corinthians 1:3-7 NRSV)

When I was a boy, my mother insisted that I write thank-you notes for my Christmas presents before I was allowed to play with them in earnest. So the day after Christmas I wrote thank you-notes before they piled up. As I have reflected on our past year together, I realized that I have not kept up with expressing my thanks and gratitude.

First, I am very grateful to God for all the blessings we have enjoyed, for truly this has been a good year. I believe that we stand on a good and strong foundation upon which to build a favorable and faithful future.

I am grateful for your generous financial support. Despite economic challenges, your giving matched our budget expenses this past year with even a tiny bit to spare. In addition, your financial gifts have paid off our Phase I debt, provided 21 deacon Christmas baskets to families in need, a wheelchair-accessible van, and a new garage to protect and store it. Beyond our church budget, you funded a very successful Vacation Bible School, sent our high school and our mid-school youth groups each on a mission trip, and you continue to give toward our Salt and Light program. In countless other ways you support our church's mission and outreach with your giving, and I thank you.

It is an amazing blessing that so many of our congregation faithfully love this church enough to commit so much of their time, talents and efforts to our shared mission. The people of this church work an amazing number of hours on the behalf of our shared ministry, usually with little or no public recognition. I see people constantly coming in and out of our church doing jobs and attending to details, not including all the hours spent at home planning and arranging. I wonder how many phone calls and emails you exchange in a year as you care for one another and work on the programs and ministries of this church. We are truly blessed with amazingly faithful servants of God who freely give their time and their passion for the mission of this church to our community and to the world. I cannot say, "thank you" enough, for all you do and give.

I am also pleased and grateful for the growth and change we have experienced, especially this past year. Without abandoning our heritage, we are moving toward new opportunities for ministry and outreach, such as our Saturday evening "Faith and Fellowship" worship service. Church members who have been around for a long time have been generous in welcoming new people into our church family. Our faithfully aging saints have gracefully invited those new folks to share in doing meaningful ministry and entrusting them to help lead us as elders and deacons. It is a very good thing that new members and families are so quickly invited to serve and participate in the full life of this church. I am grateful beyond words for the faithfulness of our long-standing members and for the participation of new members and families in our shared mission. In so many ways I see God at work in the lives of our church family and in our mutual relationships. It is my joy to serve as your pastor and share in the life and ministries of this church. I want you to know how grateful I am for your continuing friendship and support.

I am truly grateful for this past year and for all the signs of God's presence, power and promises for our future. We are blessed in so many ways. I believe that we are poised for a wonderful and exciting year ahead. We have a strong and stable foundation upon which to build a glorious future for this church, and surely the best is yet to come. Our God is always faithful and always blessing us toward new life, as we respond to the Lord's gracious love, God's call, and our church's mission on into the future.

Mission through Iglesia del Pueblo 2010

2010 was a pivotal year in the mission of Iglesia del Pueblo. A huge wave of thanks is due to the First Presbyterian Church of Las Cruces in this work.

First, the challenges! Last year was a very difficult one for immigrant families. Some from our congregation without legalized status were deported, thus dividing families and creating intense hardship. Others of our congregation have faced severe health and family difficulties. Others suffered from issues of injustice, like working for months with a promise of pay that was then denied. The problems of poverty are many, and they will continue to present difficult realities in the lives of many of our people.

On the other side of those challenges, the church – First Presbyterian of Las Cruces, the Presbytery of Sierra Blanca, the Synod of the Southwest, and the General Assembly – has acted with faith, vision, hope and sacrifice to serve the Lord of all life in a mission to facilitate ministry that brings spiritual and physical healing to those around us.

We lost between fifteen and twenty participants and prospects for our church. We gained the same number in new participants.

We formed effective relationships through the department of International Relations at NMSU that are working hard to support realistic and just immigration reform. The web of community relationships was further expanded through the area wide ad hoc committee on immigration issues that recently conducted a countywide forum that brought broad affirmation. We developed solid relationships with community organizations that have become a part of our mission every day of the week.

The staff and volunteer workers at First Presbyterian have provided loving relationships and resources for Christian Education, fellowship, and worship. The Deacons have responded to many emergency needs including food, medical assistance, and clothing. The staff of the church has generated a loving atmosphere in which our people are at home.

We have also developed relationships with the Mexican Presbyterian Church in Ciudad Juarez that have provided connections between our families here and there. Witness to our faith is being made on both sides of the border.

Two of our university students are now in southern Mexico giving six months of their lives in service at the Hogar Infantil Marsh, an orphanage where I (Pastor Hawkins) has life-long ties.

All of this, and much more, is happening because of the loving mission of the church. Thank you! Thank God! 2011 will bring more of the same. -Pastor Hawkins

The Board of Deacons serves the congregation and the community in many ways. These services include:

<u>Ushering</u> - Greeting our worshipers, handing out the service bulletin and collecting the offering. <u>Transportation</u> - Helping our church families to attend Services.

Transient meals - Providing sack lunches to transients.

Visitations - Visiting our home bound and hospitalized church family member.

Soup Kitchen - Setup teams of workers for the local soup kitchen

<u>Special Events</u> - Coordinates events such as the annual Deacon Hamburger Fry, Christmas Food baskets, and the Socks and Undies – School Supply drive for children in need.

Each Deacon is assigned to one of the six Deacon Committees above and one of the six Session Teams as well. Additionally the Deacon Moderator attends the Session Meetings to provide communication between the two Boards.

The deacons have furnished financial assistance to members of our congregation and local needy families of the community in cases of special needs. This supplied support and emergency assistance has been provided in the form of sack lunches, gas vouchers, bus tickets, medical bill payments, and rent assistance, food baskets, under wear, blankets, gifts certificates and inspirational materials.

The above-mentioned activities of the Board of Deacons are generously financed by you, the congregation. Our funds are generated by our annual hamburger fry, one-half of the loose offerings and monthly communion offerings. Additionally, your generosity helped us provide Christmas food baskets for 21 needy community and church families. You also purchased, and completely paid for, a wheel chair accessible bus and garage. Through your generosity, your Board of Deacons is able to make a positive contribution and lasting impact to our surrounding community as well as to our own community of believers. Thanks be to God!

Ministry Team: ADMINISTRATION

The Administration Ministry Team is responsible for the administration of church policy, personnel matters, financial matters, including the tracking of all church income and expenses, reporting the status of our income and budgeted expenses monthly. Elders serving on the team during 2010 were Carl Connor, Joan Rawson, and Gene Christensen. Deacons serving on the team were Mike Bartholomew, Ken Osborne, and Mel Parish.

The Administration Ministry Team would like to thank John Grant for his diligent and extensive review and reconciliation of our church financial records for 2009; and the guidance he gave us for improvements in our 2010 tracking and reporting practices. The detailed accounting practices implemented during 2009 have enabled us to provide accurate and comprehensive financial reports during 2010. We will continue to review our reporting formats as necessary to provide the various Ministry Teams, Deacons, and other non-budgeted organizations with the data they need. We will implement their format requests for 2011 reports wherever possible.

We would also like to thank the members of the Congregation for their response to our 2011 Stewardship campaign, although it was not as successful as the 2010 campaign. For 2011 we received **113** pledges totaling **\$347,577.00** compared to 2010 when we received **114** pledges totaling **\$362,860.00**. We hope that the historic generosity of the congregation will provide the financial resources necessary to continue our church's ministry during 2011.

Only two personnel actions occurred during 2010, one affecting the Christian Education Salt & Light Program and one the Buildings & Grounds janitorial services. Kristine Lambert was hired as Salt and Light & Vacation Bible School Program Coordinator after the resignation of Michelle Osborne, who needed more time to settle into her new home. Randy Calkins was hired as a part-time maintenance man and janitor to reduce the cost of outsourcing minor facility and equipment repairs.

We continued the selective revision of our Church's Employee Policy and Procedure manual. At the Annual Congregational Meeting on 28 February 2010 the Congregation voted to approve the new Church By-Laws that were approved in 2009 by the Session. We worked hard to prepare new Amendments to the By-Laws that address the relationship between the Church and the Church Foundation, as well as how to distribute the income received from the leasing of Church property. The latter was precipitated in part by the **total repayment of the outstanding Phase I Bonds** to the members who loaned their funds to the church.

This year has been a year of many blessings for the Christian Education Ministry team. We have continued to grow and reach out and draw in the community through many of the programs we offer at First Presbyterian Church.

Every Sunday, Sunday School is offered for everyone from birth through adults. Our birthkindergarten program continues to be lead by Judith Ames and Carol Goss. Our Elementary Sunday School Class had doubled in size this year! We are blessed to bring the love of Christ into these children's lives.

YOUTH DIRECTOR REPORT

This has been a very active year even more than 2009. There is so much to talk about, however there are a few things that stand out.

The first is we had other churches that are located in both California and Texas that spent the night in the youth rooms. The thing that stood out to me was the fact that so many of our youth showed up and tried to make their stay as comfortable as possible. They baked cookies, made sure they had plenty of cold water, and greeted the visitors when the churches arrived. There was a definite showing of how much these young people care and want to help others.

Another thing that stands out is how the youth have started to police themselves. It was evident when one of the youth started to use inappropriate language and the group told him that was not appropriate. I do not think that would have happened even a few months ago.

One of the best things that happened in the last year is seeing the growth in many of the youth. Last year was hard because I was still getting to know the youth and who they were and what their stories are. This year I had something to compare to and it has been really cool to see how they have grown up and in many cases come out of their shell. Even the shy ones are coming alive, interacting, and speaking up. There are a number of youth that are becoming leaders and have great potential if they can continue to control their emotions and grow with Christ. They are also showing their maturity by looking outside of themselves to help others. On more than one occasion this year they have showed up to help people clean up or do what needed to be done to help out. For instance I had an incident at my house, and I had 8 people over to my house the next day helping get the house back in order. We helped a neighbor of the Smollecks that needed help with their yard, and moved books for another couple that was moving and needed to get the books packed up and taken away. They really are showing a giving heart and looking for places to serve those around them.

We were also blessed this year with many of our youth bringing their friends. This has contributed greatly to the growth of this group over the past year. We started January with few seniors and 8th graders. That combined with a number of youth moving from our area dropped our numbers, over the summer. That started to reverse the second week of Salt & Light when our numbers especially in middle school, really started to take off. We went from 6 to 16 over that period. The high school went from 11 to 17 over that same period of time. All the growth is from youth outside of the church. It is friends bringing friends. It is very exciting to see all the new faces and that fact that they are staying around is very encouraging.

One of the goals for this past year was to average three events a month. The breakdown was suppose to be one service project, one fundraiser, and one fun event. The other goal was to give parents the opportunity to meet with me and other parents so I planned on 4 parent meeting taking place over this past year. This was pretty well accomplished. We had 11 fundraisers, 19 service projects, and 15 fun events or parties and 4 parent meetings. In total we had 56 special events or activities over this past year that would include planning meetings and the 4 parent meetings. This does not include weekly youth group nights of which we had forty. For more information please contact Mark Hellman.

There are a couple of needs that we have in the youth program. The first is we desperately need volunteers. As a group grows there needs to be more adult leaders to keep everything running smoothly. Helping to greet the youth when they arrive, get to know them a little, giving some

more discipline when needed, and encouraging the youth to reach out beyond themselves. Possibly even being a mentor could mean a great deal and make and impact on the rest of their lives. This is a job that no one person can do alone so please prayerfully consider volunteering to help the next generation.

The other thing that we need is prayer. This is by far the most important thing that we need this year. Specifically prayers as stated in the previous paragraph for more adult leaders, but also youth leaders that will rise out of the youth themselves. Prayer is the thing that will get us through the next year and continue to grow what is going on here at First Presbyterian Church.

The "congregational life" part of our committee refers to ministering within our congregation, and finding ways to keep our congregation connected. The "outreach" function refers to reaching out into the community to bring new folks into our congregation. The two functions are related, as the congregation is made vibrant and fresh by the infusion of newcomers, and newcomers feel welcome when the congregation is active and connected. Our committee was very active during 2010, and we hope to continue that trend in 2011 with new imaginative events designed to bring our congregation closer together and reach out into our community.

Some of the recurring activities we continue to sponsor are the after church fellowship time, the movie night during the summer, and various dinners and "get-togethers". The after church fellowship time has been continually improved so that hosting is spread out over all the church's ministry teams. The intention with this program is to make the process very straightforward so that the host views this as an opportunity and not a burden - we believe we have accomplished this goal. The movie night during the summer was lightly attended on some evenings while drawing a good crowd on others. We plan to continue these events next summer with increased visibility within the congregation. We will continue to support any opportunity to bring members of the congregation together, and the tried and true method of feeding each other always works.

Our committee initiated several new events this year. The first was a Bingo Night, which was a very enjoyable evening of eating, making new friends, and – of course – playing Bingo. We also held a very successful wedding vow renewal ceremony in June, and hosted the fourth annual Trunk-or-Treat event on Halloween. For the second year in a row, CL&O coordinated a well-attended Thanksgiving dinner on the Sunday before the holiday in an effort to draw in college students from NMSU and introduce them to our church family. The team has also begun planning activities for the upcoming Gospel of John performance that CL&O will be hosting on February 13, 2011. This is a major undertaking that will be the primary focus of the committee for the first part of 2011, and we hope it will be an excellent opportunity to reach the community and bring them into our church.

In the outreach area, our committee focused on advertising and making personal connections with newcomers. We have decided to reduce our Yellow Pages ad in the coming year to invest the savings in other publications, such as Las Cruces Magazine. We have begun handing out visitor gift bags containing literature about our church, cookies, and name tags. The idea is that elders, deacons, and other members of the congregation will be able to easily identify visitors who carry these bags so that they may take the opportunity to introduce themselves and welcome the newcomers. We also hope that every event we sponsor will bring in friends and neighbors to come and meet our church. This area also spills over into other committees and throughout the congregation. One of the continuing difficulties is figuring out what works and what doesn't in the outreach area. To this end we will focus in the coming year on better tracking of the visitor pads used in the worship service. We will continue to look for new and better ways to spread the good news and give folks a chance to come and see for themselves the vibrant life of our church. More important is to reach people who don't know Jesus and look for opportunities to be a witness to the new life we have through him.

PRESBYTERIAN WOMEN IN THE CONGREGATION

Presbyterian Women is an independent organization with its own leadership, program and budget. It is organized with the consent of the Session, and is a member of Women of the Presbytery of Sierra Blanca, the Presbyterian Women of the Synod of the Southwest, as well as the Presbyterian Women of the Presbyterian Church (USA).

Presbyterian Women (PW) is organized into circles to provide opportunity for Bible study and fellowship. The circles meet at various times to provide meeting times convenient for the members. Each group selects its own leaders and study materials. Overall leadership is provided by a Coordinating Team consisting of a Moderator, Treasurer, Secretary, Coordinators of the Circles, and Coordinators of programs.

PW members are given the opportunity to participate in supporting local missions through offerings at circle meetings. Local missions supported during 2010 included Gospel Rescue Mission, Casa Peregriños (food bank), St. Luke's Clinic (health care for homeless or near homeless people), The Bridge (NMSU Campus Ministry), Los Niños (child care for children of homeless people, and La Casita (a part of the Border Ministry supported by the Presbytery of Sierra Blanca). In addition to monetary support, various in kind contributions of food, clothing, bedding and other specific needs are supplied.

National programs were supported through donations to the Offering of the Least Coin, The Birthday Offering, and the Thank Offering.

PW publishes a yearbook annually to outline meeting times, rosters of circle and study groups, the budget, and other information.

PW is a member of the Church Women United and participates in its programs.

Memorial Student Aid Fund: This fund was established in 1965 with the money realized from the sale of a manse (which PW had built sometime in the past). The fund was invested with the stipulation that the principal was to remain intact, only the interest was to be used for scholarships. The funds were to increase only through donations. The fund is now invested in New Covenant Funds with General Assembly oversight. Because the fund has suffered loss during the current economic situation, no dividends have been issued, and therefore no scholarships were awarded in 2010. The value of this investment was \$6,930.03 as of December 31, 2010.

Salt and Light/Vacation Bible School

Every Wednesday night, through the Spring and Fall, First Presbyterian actively devotes itself to helping children become stewards of Christ. Our program is geared towards grades K-12. Thanks to dedicated and loving volunteers, we are able to reach out into the community providing God's word and love, through music, bible study, fellowship and a warm family-style meal.
