President's Corner

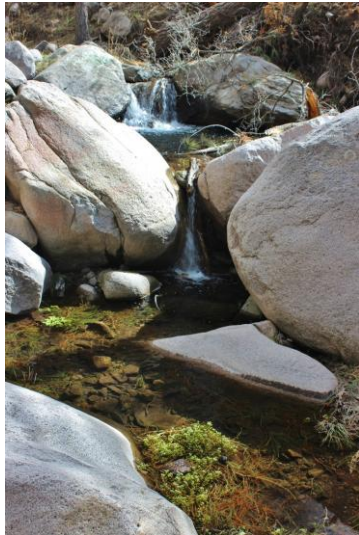

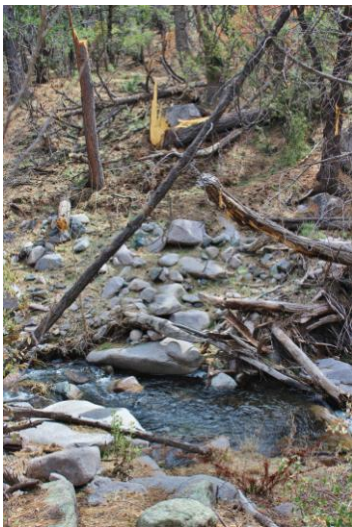
Most of New Mexico lacks the large sorts of rivers that comprise the most famous trout fisheries in other parts of the western United States. Yes, we have the San Juan and the upper Rio Grande, but most of our cold water fisheries are small to medium sized streams. Many of our trout streams are actually the small headwaters of rivers that become slow and warm at lower elevations; some even shrink or dry up altogether as they leave the mountains. Yet, small headwater streams are critical to protecting and restoring native Rio Grande cutthroat and Gila trout populations. In addition, they are generally clean, cold, and beautiful, and they often provide the solitude many fly anglers seek. Of course it is fun to travel to large rivers and catch large fish, but we should also embrace our small and very small streams: our hidden waters. Our hidden waters provide us the opportunity to become skilled at fishing them... skilled at fishing places that would confound anglers who routinely fish large rivers such as the Roaring Fork, the Green River, the Madison, the Colorado, or the Yellowstone. So, in celebration of our small streams, and the fishing opportunities and challenges they afford us, I offer the first in a series of occasional reports on selected hidden waters from our region.

Hidden Waters Notebook: Three Rivers Creek

Three Rivers Creek drains the northwest slopes of Sierra Blanca in the Sacramento Mountains. Until recently, it was easily accessed via a trail from the Three Rivers campground about 8 miles east of Tularosa and the Three Rivers Petroglyph Site. About four months ago, the area was hit by a massive storm accompanied by high winds that knocked down many mature trees, including junipers at the lowest elevations and ponderosa pines further upstream. The windfalls are still there, partially or completely uprooted, or even snapped off close to the ground, strewn about like so many match sticks. A few years earlier, much of the lower portion



of the drainage was scoured and rearranged by massive flooding during the summer monsoons of 2008. Participants in my archeological field school that year



were awakened by the roar of the floods passing the petroglyph park and the sounds of boulders the size of basketballs crashing along the river bed. In the morning, we saw that mature ponderosa pines had been uprooted in the wilderness area and floated downstream nearly all the way to Hwy 54.

So, on my visit last month, I was curious to see whether Three Rivers Creek had recovered. First, the good news.

Three Rivers Creek has indeed recovered, and it is populated with many brook trout ranging from 6–12 inches in length. In years past, I only saw small rain-bow trout in the lower reaches of the stream, so it

would seem the brookies were naturally transplanted from the headwaters during flooding. The water is clean, the stream bed is gravelly, and when I visited during mid-March, the water temperature at midday was 44 degrees. The aquatic insect fauna seems to be abundant and varied, including midges, at least two kinds of mayflies, some pretty large caddis, crane fly larvae and pupae, and aquatic worms (see photos). All these insects were collected with two quick dips of a small aquarium net, a recovery rate higher than I've ever had

in similar sampling efforts on the Rio Penasco. The brookies were so enthusi-



astic about taking my beadhead PT that I didn't even try imitations of the other insects. I encountered two other fly anglers on the creek just above the USFS parking lot, so



there are some other folks already getting reacquainted with the fishery.

Now the bad news... With all the broken and toppled trees, getting to the water can be a real challenge. In some places it is possible to work two or three substantial pools before ducking under or crawling over large tree trunks crisscrossing over one another. In other places, it is difficult to even identify the old trail, let alone follow it. About the first mile is manageable at present. Even in the areas where it is possible to reach the water, presenting the fly is a challenge. Note that I didn't call it "casting;" instead, dapping, swinging the fly, or using a bow-and-arrow cast or short side arm flip will be called for. I was using a March Brown 4wt rod that converts down to a 6 ft length, and there were still some areas that were

very tight. So, it seems that Three Rivers Creek offers plenty of opportunity to practice our small water skills. It will be even more challenging once the willows leaf out in a few weeks. I contacted the Lincoln National Forest office to see if they had plans to clear the trail. Trail repairs are scheduled for May, and will be conducted by Smokey Bear ranger district personnel and an Arizona Conservation Crew comprised of military vets, but for now, fishing Three Rivers Creek will require real bushwhacking.

Nevertheless, I'm still curious about the middle and upper portions of the creek, and I'll be out there again soon trying to find a way up the drainage. If any of you find it before I do, please let me know.

Don't forget to renew your New Mexico fishing licenses and club memberships before heading out to the water this month.

Rod building is going great. We have 8 Vets building fly rods that I hope will be completed in the next couple of weeks.

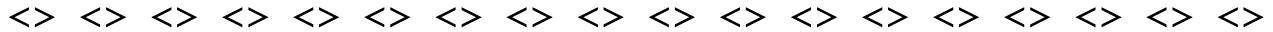

MVFF Board Meeting Minutes

Monday, March 21, 2015

The MVFF Board meeting was called to order at 7:00pm in the NMDG&F Conference Room by President David Carmichael. Board members present were David Carmichael, Jim Sorenson, Gary Mann, John Kennedy, Chuck Mueller, Bob Silver, Dennis Lanpher and Ray Rodriquez. Non-Board members in attendance were Ron Bellerose, Tom Wobbe, Jim Hulsey and Paul Turner.

1. The minutes of the February 15, 2016 Board meeting were approved as published in the March, 2016 issue of the newsletter.
2. The Treasurer reported a balance of approximately \$11,400. The Treasurer's report was accepted and approved.
3. Tom Wobbe reported that the Club has approximately 336 members, and the Club is still growing. Over 100 members are couples. The membership rolls will be checked soon to eliminate the names of members who have not paid annual membership dues.
4. Ron Bellerose reported on Project Healing Waters. Ron recently returned from a PHW Conference in

Orlando, Florida. Topics discussed were well received and informative. The Conference was sponsored by a VA Grant. Ron found out that PHW directs only 16% of its revenues to salaries and overhead, and the remaining 84% goes to projects and needed supplies. On March 30 there will be fly tying for wounded warriors at the VA Clinic. On May 14 & 15 there are 2 days of fly tying and fishing at the lease for the Wounded Warriors Transition Team. Additional programs and trips will be planned.

5. The next stream improvement project at the lease will probably be towards the end of April.
6. The Kids Clinic is scheduled for April 2.
7. Meredith Campbell will be our speaker at the April General meeting.
8. There was a brief discussion concerning various Conservation groups which request the Club's support on various issues.

The next Board meeting will be April 18, 2016.

Meeting was adjourned at 8:12pm.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.

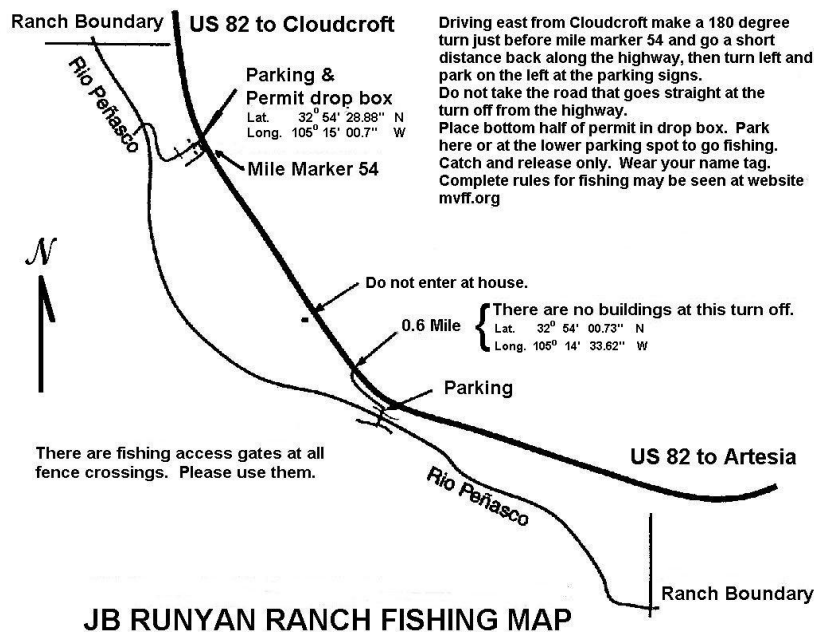

Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880), Tom Wobbe (575-522-5437) and Donna Mabie (575-522-3810) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
