## President's Corner

David Carmichael



In several past newsletters I have commented on the range of activities supported by the MVFF club. One of the most important and rewarding of these activities is our club's participation in Project Healing Waters. PHW is a unique national program built upon community based non-profit volunteerism dedicated to the physical and psychological rehabilitation of active duty military personnel and veterans. Participants are introduced to the therapeutic benefits of fly tying, casting, rod building and fly fishing. The two MVFF programs (Las Cruces and El Paso) are among the nearly 200 such programs around the country; there are only three in New Mexico and six in Texas. The activities emphasized in our PHW programs are not only central to the club's stated mission, but they are a meaningful way to give back to service men and women who have given so much to our country.



Project Healing Waters is enormously successful, as indicated by the responses of many of the partici-

pants. One statement included in the PHW media materials includes the following statement:

*Being outdoors with nature and with PHW volunteers somehow eased the physical pain and brought peace to my mental being. For the first time, my days were not dark, somehow there was a light at the end of the tunnel. [SFC, USA]*

The responses to our own local program, such as the fly fishing trips to the club lease on the Rio Peñasco have been enthusiastic as well, as indicated by comments received on a hand painted, hand lettered thank you card from 2016:

*I have a great new hobby because of you guys. Thank you!*

*We really appreciate you! Thanks for helping heal our soldiers!*

*Thank you so much for your generosity, hospitality and friendliness during our trip. The food was phenomenal! Had a blast fishing.*

If you haven't already done so, I invite you to visit the national PHW website to learn more about the program, and especially to view the videos that provide compelling evidence of the positive impact of Project Healing Waters on the lives of real people ([www.projecthealingwaters.org/video-gallery/](http://www.projecthealingwaters.org/video-gallery/)).

As with all MVFF club activities, our ability to participate in PHW is built around the efforts of a handful of key volunteers who have made the commitment to organize, document and participate in the various educational activities and outings associated with the program. Ron Bellerose has been a real champion as Project Lead for 2 PHW programs, through the Las Cruces Vet Center, and William Beaumont AMC in El Paso. The Las Cruces program is one of only three in New Mexico, the others being located in Taos and Albuquerque. There are only 6 programs in all of

Texas, and the next closest one is in Amarillo, 440 miles away. So, for southern New Mexico and most of far west Texas, the MVFF programs are the only opportunities our soldiers and vets have to participate in PHW.

Serving as Project Lead is been a labor of love for Ron, and although he has received a lot of help from other volunteers in the context of fishing trips and fly tying classes, the job of coordinating all the activities has grown over the years, and he could really use some help. Although some of the board members have been asking around for the past couple of months for someone to help out, I'm now reaching out with an appeal to the entire membership. Please give some thought to helping Ron as an Assistant Project Lead so the club can keep our Project Healing Waters program vital and effective. Contact Ron, me, or one of the board members if you're willing to take your involvement to the next level. Thanks everyone.

Last month we hosted a visit from Bob Widgren who drove down from Albuquerque to teach a couple of fly casting classes at the Alumni Pond at NMSU. As luck would have it, the weather was chilly and blustery,



making it pretty challenging for accurate casting. Fortunately, Bob took the opportunity to teach various tricks for making serviceable casts in windy conditions, and as it turns out, that information has been

very timely for anyone fishing the lease waters in recent weeks. The club lease is fishing well, but it has been windy, and without the recent instruction from Bob, I'm sure members would be making even more fly offerings to the streamside vegetation. The cross-body cast has served me well on the Peñasco recently, especially in the wind. Thanks to Bob and Lee for making the trip, and thanks to all the club members who set up equipment, attended the casting classes, and hosted our guests at mealtime.

I hope you will be able to attend the next meeting of the general membership on April 9<sup>th</sup>. Our guest speaker will be Laurence D'Alessandro, a Coldwater Fisheries Biologist with the New Mexico Department of Game and Fish. Born and raised in Santa Fe, Laurence is a 2012 graduate of NMSU with a double major in Wildlife and Fisheries Science. We have scheduled the **Willow Creek Volunteer Stream Project for the weekend of May 11–13<sup>th</sup>**. This is a fun

opportunity to get involved doing important work on one of our most accessible Gila trout streams that will contribute towards future restoration work on this watershed.

We will also be announcing the **1st Southern NM Fish-n-Photo challenge**. The purpose of this catch & release fishing event is to encourage members to get out and fish, using photography to document the variety of fish and the beautiful locations in our region. This is not a typical type of competition where the size and/or numbers of fish caught matter. Instead, each participant can submit one photo for judging, including the date the fish was caught and released, along with a description of the angling method used, and the watershed where the fish was caught (following all applicable NMDGF fishing regulations:

Anglers can select any of the open waters on public land in New Mexico south of I-40. An independent panel of judges will select the prize winners from the entries received. The photo should be visually appealing, giving a clear picture of the fish that enables identification of species, and should be taken with appropriate care for handling and release. All cold or warm water species caught using legal angling methods are eligible. We have an assortment of prizes to award, and there are no entry fees! Submitted photographs will be displayed publicly. The time frame for the challenge is: May 1 – Sept 30, 2018.

### Fishing Reports

Recent reports for the Rio Penasco

**Tom Johnson – Saturday, March 31, 2018** — I had a great time at the lease catching fish and enjoying the partly-sunny day! I arrived about 9:30am and left about 2:30pm. I fished from the lower waterfall to the middle waterfall. I started catching chubs and rainbow trout on a two fly rig, #20 cdc trico emerger and #16 pheasant tail. However, I switched to a #18 parachute blue wing olive when I saw fish surface feeding on the trico and blue wing olive mayflies hatching. I caught my share of chubs, but in most pools, tailouts, and along the seams, I got rainbows consistently. Most of the places you thought there



should be fish, had some. I caught about 15 rainbows, most on parachute BWO or adams and cdc trico emerger. Since the dry fly fishing was good enough, I barely fished nymphs or the deep holes. That's my fish story and I'm sticking to it! Photos follow.



**Jim Vandagriff – March 10, 2018** — We started at the upper fence line, crossed the river and fished down to the lower arroyo. From around 10:30am to almost 5pm I spent the majority of the time helping my friend and his son with tying on flies, untangling line and general fishing techniques. (Their first time fly fishing). They caught about 5 or 6 chubs and had a great time.



In between all that, I managed to fish a bit and caught a couple of chubs and four of these decent sized trout just below the upper washed-out bridge, in those narrow deep sections. Fishing a double nymph rig, point fly being a size 12 (custom see image) and a smaller tag fly size 16 Frenchy and/or ShopVac. They seemed to be taking that larger fly, the water wasn't super clear. Tight quarters in there for sure.

### MVFF Board Meeting Minutes

Monday, March 19, 2018

The MVFF Board meeting was called to order by David Carmichael at 7:05pm in the NMDG&F Conference room. Board members present were: Robert Ardivino, Jeff Arterburn (Secretary), David Carmichael (President), Jim Hulsey, Tom Johnson (Vice President), Dillen Martinez, Bob Silver (Membership) and Chuck Mueller (Treasurer). Board Members absent: Jim Sorenson. Non-Board members in attendance: Ron Bellerose, Zach Speir (VP NMSU American Fisheries Society) and Esteban Quirante.

- Meeting Minutes.** The minutes from the February 19, 2018 Board meeting were approved as published in the March 2018 issue of the newsletter.
- Treasurer's Report.** Chuck Mueller presented the Treasurer's report with current account balance statement of \$10,302.97, incorporating a correction of \$300 that had not been recorded, and the report was accepted by the Board.
- Membership Report.** Bob Silver reported 214 active members, with 8 new members joining since the last report. He is planning to send renewal notices via email. The membership renewal function through PayPal is now operational. Jim Hulsey has set up the new website so that the PayPal transaction fees are applied to the purchase price.
- Project Healing Waters.** Ron Bellerose reported that he is canceling the March 28<sup>th</sup> fly tying session. He will be taking 6 veterans to Silver Creek, AZ March 25–28<sup>th</sup>. He will also be halting PHW activities during the period June – August.
- Gila/Rio Grande Chapter of Trout Unlimited.** Jeff Arterburn reported that the dates of May 11–13<sup>th</sup> are scheduled for the Willow Creek Volunteer project. The GRG–TU has budgeted \$510 for the NMSU student travel costs. A request for MVFF matching funds (\$510) was presented and approved by the board. Jeff provided a draft version of the information sign that is being developed for Willow Creek and he will request comments and suggestions. The GRG–TU is planning to submit a Trout Unlimited Embrace a Stream (EAS) grant proposal to fund the citizen science project on Willow Creek, and coordinated participation in the funded watershed assessment project managed by Natural Channel Design. The GRG–TU will hold a social event for TU members in April, and is initiating a "Southern NM Fish–n–Photo challenge" this summer with prizes to be awarded. The GRG–TU Board Members meet regularly on the 3<sup>rd</sup> Mondays of the month from 5:30–6:30pm at the Game II, 4131 Northrise Drive, and anyone interested is welcome to attend.

6. **NMSU American Fisheries Students.** Dillen reported the students really enjoyed the fly tying session and fishing trip to the Rio Penasco. Several are interested in doing more of these activities. This time only a couple of MVFF volunteers were able to participate, and hopefully next time the scheduling will be better. He has confirmed three volunteers who will help with the Kids Fishing clinic, and will continue recruiting. The department awards banquet date will be set for the 3rd week in April. Dillen will check in with Dr. Caldwell to confirm those details. The MVFF board agreed to donate a membership, permit and hat for the awards banquet.
7. **Presentations and Events.** The April 9<sup>th</sup> meeting will feature Laurence D'Allesandro from NMDGF with a presentation on the new "special water" fishing regulations. David Carmichael will host the May 14<sup>th</sup> meeting, with a presentation on "Why bother keeping a fly fishing journal?" Due to continuing problems with the NMDGF projections system, Chuck will bring the MVFF club projector for the meetings.  
The MVFF Lady Anglers have scheduled May 18-19 for their spring trip to the Rio Penasco. Their fall trip is planned with the Wolf Creek Anglers for Sept 20-24, with interests raised during the presentation by Brad Shellenberger to the club at the March meeting,  
The club is planning to host the Fly Fishing Film Tour 2018. Likely dates were discussed and the preferred options of Sunday Oct 14, 21, or Nov 11, 18 were identified.
8. **Rio Peñasco Lease.** David Carmichael met with Jim Ellett and discussed the reports of poaching. A motion was made requesting allocation of funds for stocking 500 fish. The motion was approved and stocking will be scheduled for mid-April.
9. **Kids' Fishing Clinic.** Tom Johnson provided an update on the Kids' Clinic scheduled for March 24<sup>th</sup> 2018. All arrangements are in place, and he has updated the flyers, advertising is getting word out, he has arranged for pizzas and will pick up drinks, tables etc. Sportsman's Warehouse has donated prizes, and the club appreciates Nicholas' support with this. Volunteers are reminded to bring their own folding chairs.
10. **Other discussion items:**The NMSU Scholarship application submission window closed March 1<sup>st</sup>, and the selection committee should be making recommendations for the Norm Mabie Scholarship award soon.  
Chuck presented the need for MVFF to purchase a new coffee maker and thermal containers. Options for different commercial products were discussed and the board approved a motion for funding up to \$350.  
The Gila National Forest Plan Meeting will be held at the Las Cruces Convention Center Friday March 23<sup>rd</sup>. 9-11am. Chuck will plan to attend.
11. The next MVFF Board Meeting is scheduled for April 16<sup>th</sup>. Chuck will pick up the key.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.

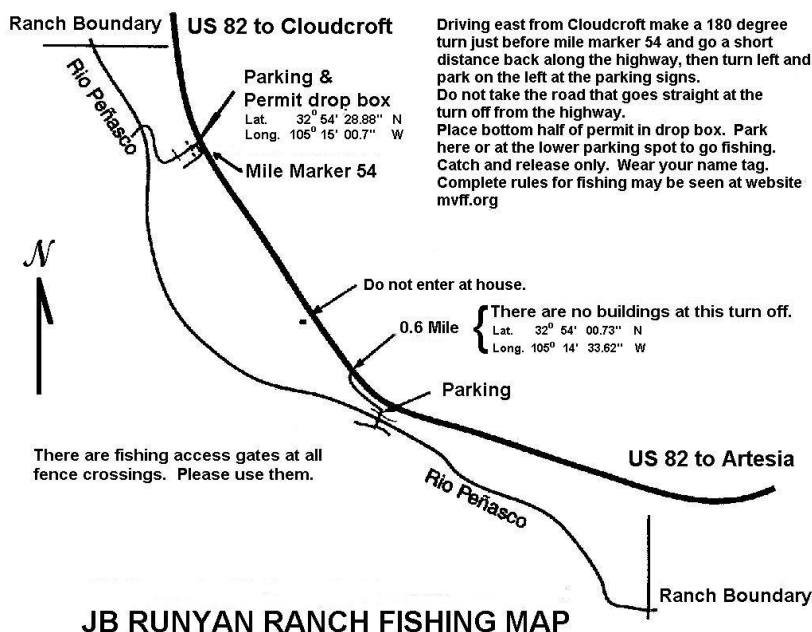

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880) or Bob Silver (575-522-6325) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page ([mvff.org](http://mvff.org)) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for guests.

### Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
