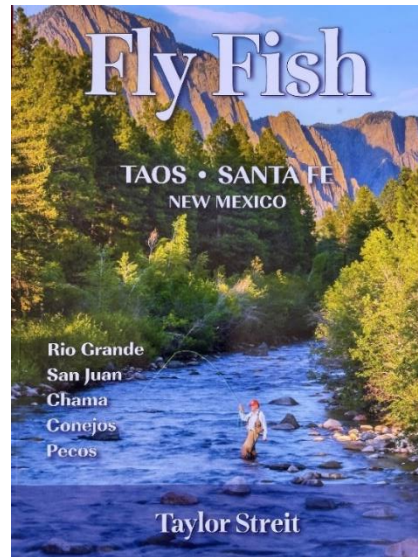
### Club News: In-Person Meetings Restart



I'm happy to announce the return of in-person meetings of the general membership. In the past, we have had our general meetings

at the NMDGF facilities on the second Monday of the month, followed by the board meeting on the third Monday of the month. However, for the time being, NMDGF is limiting groups to one meeting per month, so we have reserved the facilities for April 11, and May 9, at 7pm. Pursuant to state protocols, all groups using the conference room will need to have attendees sign a COVID waiver. A copy of the waiver is provided elsewhere in the newsletter. You can print it out and complete it in advance of the meeting, or there will be blank forms available at the meeting.

Our guest speaker will be Taylor Streit, well-known New Mexico fly-fishing guide and author. Taylor was born in New York's Hudson River Valley, near the Catskills, where he started fishing at the age of 7 or 8. He relocated to Arroyo Hondo, New Mexico in 1969, and opened the Taos Fly Shop in 1980. He has been a professional guide for more than 40 years, and in 2001 he was inducted into the Freshwater Fishing Hall of Fame. Taylor will discuss his latest (5<sup>th</sup>) book, *Fly Fish Taos/Santa Fe, New Mexico*, a guide book on northern New Mexico, which has been ten years



in the making. Taylor will have copies of the book for sale at the meeting, and if you already own it, bring it to the meeting and get it signed. Taylor will also discuss

the current forecast for the upcoming trout fishing season in northern New Mexico, and he will share some information about the stream access issue we've been following in the news.

**Environmental News**

The much debated, and intermittently enforced Clean Water Act turns 50 this year, and a number of research groups are marking the anniversary by examining its efficacy. One such group, Green Matters, has summarized and provided a link to *The Clean Water Act at 50: Promises Half Kept at the Half Century Mark*, a study released by the Environmental Integrity Project, March 17, 2022. The study was

conducted to determine the extent to which the Clean Water Act has accomplished its intended purpose of reducing pollution and improving water quality throughout the United States. More specifically, the goal of the Act was to make rivers and lakes across the country safe for drinking, fishing, and swimming. Unfortunately, that noble goal has not been met. In fact, the overall findings of the report indicate that 51% of the rivers and 55% of the lakes studied remain too polluted for recreational use. 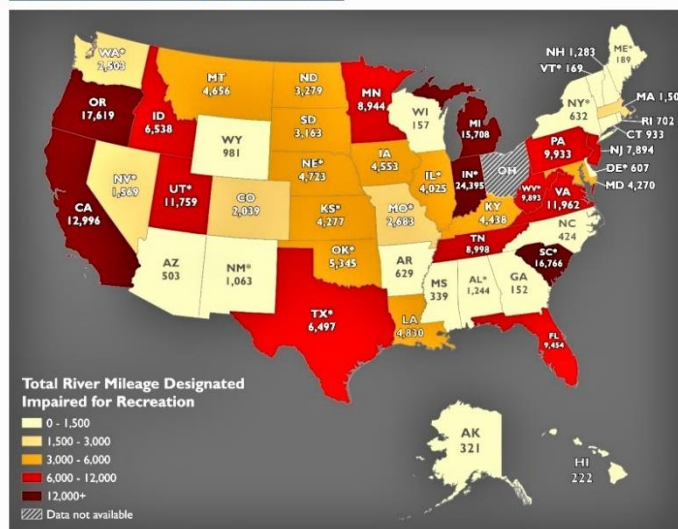
I suppose if there is any good news in the CWA report, it is that New Mexico has many fewer polluted water sources (23%) than many other states, such as Michigan (95% impairment), Indiana (73%), and Minnesota (57%). The accompanying map shows the number of impaired river miles by state, and the data for each state can be found in the CWA report linked here [[CWA-report-3.23.22-FINAL.pdf \(environmentalintegrity.org\)](https://www.environmentalintegrity.org/CWA-report-3.23.22-FINAL.pdf)]. It would seem that those of us who care about fishing, swimming, or drinking non-polluted water should be keeping a closer eye on those activities that impact water quality (mining, drilling, and agriculture), and on the state and federal agencies that are tasked with regulating those activities

for the public good. Be careful where you wade.

**Leaders and Tip-pets**

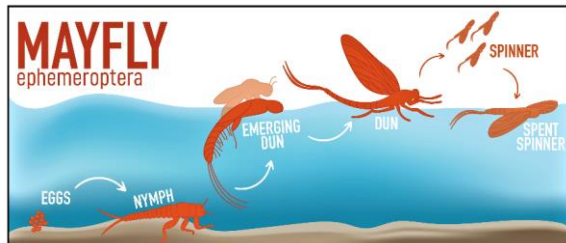
For those members who are new to the club, or new to fishing the club lease on the Rio Peñasco, it is worth pointing out that we are fortunate to have home waters on a spring creek that produces mayfly hatches all

year round. It is often possible to entice a trout on dry fly patterns, such as an olive Comparadun, a parachute Adams, or Purple Haze, even in the middle of winter. Of course, the timing of the hatch, and the size of the mayflies vary by season, with winter hatches of smaller flies coming off later in the day than they do in the summer. Learning the details of those behaviors is part of the fun of becoming familiar with the club lease. Nevertheless, it's true that more than 90% of a trout's diet is from food eaten underwater. Not only are aquatic insects available underwater for most of their lifetimes, there are other food items, such as worms, snails, and chubs that never transform into an airborne food source. Therefore, it behooves the fly angler to become familiar with the appearance and availability of underwater fish foods. To get started with mayflies, here is a link to a nice little presentation by Trouts Fly Fishing on the life cycle of the mayfly. Once you are familiar with it, you'll probably want to carry at least a couple of different patterns representing nymphs and emergers, as well as a pattern to imitate spent spinners. **GRG-TU for MVFF April Progress with preparations for GRG-TU habitat restoration work in 2022**

We are making progress securing the approvals, agreements and permits that will allow out Gila/Rio Grande Chapter of Trout Unlimited to begin habitat restoration on the Little Turkey Creek tributary of Willow Creek in the Gila National Forest with funding from the NM Environment Department River Stewards program. We will be meeting with the agency staff and contractors for a detailed on-site planning session to finalize logistics and map out the work sites. This

project involves hand-built construction using natural materials and requires a vigorous volunteer base to make it all happen. We are planning to provide delicious camp cooking in a beautiful part of the Gila, and a great opportunity for you to help restore critical habitat for Gila trout.

A parallel project is beginning for habitat work on the upper Black Canyon Creek in the Aldo Leopold Wilderness, and we participated in an on-site visit last week. This project will use similar methods



over several miles of creek and will provide additional opportunities for volunteers to help out. This project funding was awarded to Dan Taylor from Bat Conservation Intl. and will most likely begin in Fall 2022. We are hoping to draw volunteers from many different groups interested in conservation and stream habitat restoration, which will give you a chance to meet new friends who share our dedication to healthy watersheds and riparian ecosystems and all of the biodiversity they support!

Please stay tuned for additional announcements as we begin to schedule volunteer events, and we hope to see you at one of our volunteer projects or elsewhere on the water!

The scholarship recipient is selected each April by the faculty members of the NMSU Department of Fish, Wildlife and Conservation Ecology.

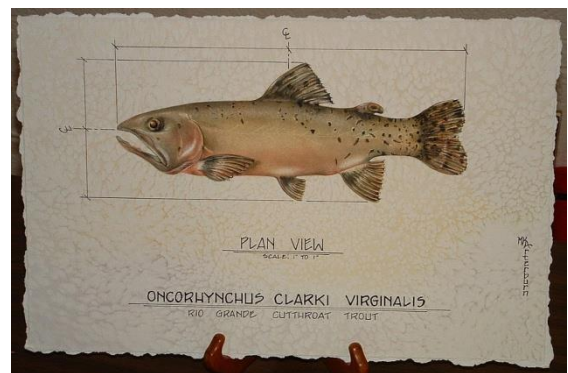

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.

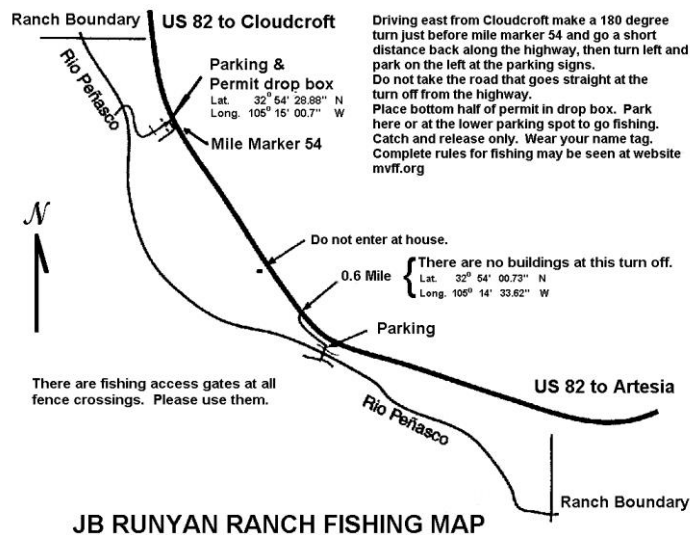

### Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880) or Bob Silver (575-522-6325) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed or, if you had rather, you may pay through PayPal. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Bob Silver. In addition, members may purchase 1-day, 1-time permits for up to 2 guests per trip. Each guest must have a permit. One-time means a person can go as a guest one time only and must be a member to ever go again.

#### Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.

## COVID-19 Liability Release Waiver
