MVFF Board of Directors Meeting

Monday, February 19, 2024 Submitted by Jeff Arterburn

The Board meeting was called to order via Zoom by Bob Silver at 7:08pm. Board members present were Jeff Arterburn, David Brown, Dave Lucoski, Chuck Mueller, George Sanders and Bob Silver. Not present: Robert Ardovino, Jeremiah Blount and Jim Hulsey.

March 2024

- 1. Approval of minutes: The minutes from the Board meeting held January 15, 2024, were accepted as published in the February newsletter.
- 2. Treasurer's Report: A motion to appoint Dave Lucoski to the MVFF Board of Directors was made and approved unanimously. Dave agreed to serve as the Treasurer. Chuck will initiate this transition and provide the training and documents needed for Dave to perform this role. Chuck, Dave and Bob will meet at the Wells Fargo Bank located at 425 S Telshor Blvd, Las Cruces, NM, 88011 on Friday Feb 22, 2024 to complete the paperwork and signature authority. Chuck will step down but will help Dave renew the club's certificate of incorporation in May. Chuck Mueller presented the Treasurer's report noting the current available balance of club accounts is \$6,816.34. The report was accepted as presented. Bob has additional revenue from memberships and permits that will be added.
- 3. Membership: Bob sent out 76 emails to longexpired memberships (2019), and will repeat to update those with expiration dates from 2020-23, keeping track of all addresses ~402 on the listserve.
- 4. Gila/Rio Grande Chapter of Trout Unlimited: Jeff summarized recent information on the developing Trout in the Classroom (TIC) programs provided by Pat Lamb in Ruidoso and Eric Head's efforts to obtain authorization for Gila trout eggs for the Stout Elementary School in Silver City. The plan for a Spring 2024 Volunteer Work Project in early April is being canceled and will be rescheduled for May 3-4, arriving the evening of 2 May 2nd and leaving after breakfast on May 5th. Dinner will be provided on the 2nd, all meals covered on work days. TU and MVFF Volunteers are needed to help out with other events including the June 1st Aldo Leopold Kids' Fishing Derby at Lake Roberts, and the Kids Fishing Derby at Grindstone Reservoir. We are also hoping to help out by organizing river/lake trash clean-up projects.
- 5. Old Business: Chuck provided a summary of

the expenses associated with the banquet, and considering the attendance the average cost was ~\$45/person attending. The amount of food provided would have covered a larger group, and with increases in attendance the "ideal costs" of ~\$25 could be achieved. The Board discussed possible contributing factors for attendance but did not identify any specific strategies for increasing numbers. Bob suggested that increased participation in activities through the year may be the best route for increasing banquet attendance.

- 6. New Business:
 - Bob reported that the owners of the Mayhill Trailer have changed plans so that will not be immediately available for rental, however, they are planning construction of a Casita that will be open for rentals. More details will be provided when they are available.
 - The old and new MVFF logo's were discussed with regards to obtaining embroidered hats, patches, decals, license plates etc. Bob will discuss the logo designed by Dave Carmichael with him and with Chuck will evaluate options for printing new products.
 - David Brown discussed plans for fishing trips for 2024: two San Juan trips are planned May 6-10; and September 30 – October 4; a trip to South Fork CO is planned for July 8-12. Dave has started sign-up lists and is working on the selection of housing options and guiding arrangements with Evan Claassen.
 - The planned speaker for the March meeting will be professional fly fishing guide Evan Claassen, most likely by zoom. Bob will contact Robert about possibly presenting at the April meeting. Bob may present on his Tarpon fishing experience in May.
- **7.** The next MVFF Board Meeting is scheduled for Monday March 18, 2024.
- The meeting was adjourned at 8:41.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575–635–5381) or Bob Silver (575–522–6325) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575–687–3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed or, if you had rather, you may pay through PayPal (preferred method). Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Bob Silver. In addition, members may purchase 1–day, 1–time permits for up to 2 guests per trip. Each guest must have a permit. One-time means a person can go as a guest one time only and must be a member to ever go again. If you do not place a signed/dated permit in the proper receptacle before fishing, then you have not agreed to the terms stipulated on the permit and will be trespassing on private property.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
