

The club has just finished the Quinlan Ranch trip. We had 6 members on this trip. They all had fun fishing 3 days in Northern New Mexico and Southern Colorado. Take a look at the photos in this newsletter.

Our next club trip is October 10th through October 13th. So far, we have 11 members signed up for this trip. There are spots available at the Octagon Inn and three rooms available at Fishheads. You will enjoy 2

full days of fishing on the San Juan with some time to fish Thursday afternoon and Sunday morning before heading home. Thursday evening we meet at Fishheads for dinner. Friday and Saturday evenings we have dinner at the Octagon Inn, we ask that you bring a side dish to share at these dinners. Bring your own beer, wine or booze; we will supply water and soda. The cost for a three night stay at the Octagon Inn is \$150 per angler. For those members staying at Fisheads the cost is \$94 + tax per room per day. We have arranged for guides through John Tavenner and Noah Parker on Friday and Saturday. The guide trips will be full day floats or wades. I am still in the process of finalizing the cost and will have that by the September newsletter. Full payment for the Octagon Inn and guided service are due no later than September 30th. Quinlan Ranch Trip

The Club trip to the Quinlan Ranch was held 17 July through 21 July and consisted of 3 days guided fishing and 4 days board and lodging. Six members participated in the trip, namely: Jim Sorenson, Mary Hoffman, Duane Sorenson, Jim Hulsey, Ray Rodriquez and Blaine Goss. If you see any of us walking around with a big grin on our face you will know why, we had a great trip.

For fishing we divided into 2 groups of 3 each. The first group, known as the "Sorenson Trio" consisting of Jim Sorenson, Mary Hoffman and Duane Sorenson, was guided by Shane Parker and the remaining members, known as the "Other Group", was guided by Noah Parker. Many of you know the Parkers as they have made presentations to the club on several occasions. They are excellent guides and have exclusive guiding privileges on several ranches in the area. They operate *Land of Enchantment Guides* and a link to their website is on the MVFF website.

On day 1 both groups fished private waters on the Navajo River, although on separate ranches. Neither group caught a lot of fish but did catch some really nice ones with several being in the 17"-20" size. It was cloudy all afternoon but the rain held off until about the time we were getting off the river. The

Navajo is a really nice river and I urge you to fish it if you get the chance.

On day 2 the "Other Group" fished the Abeyta Ranch property on the Rio Conejos in southern Colorado. This was by a prior agreement from the night before, a die was rolled and a six beats a one every time. Again we didn't catch a large amount fish but did catch some very nice ones and lost some as well. Again it started to rain as we left the river. The "Sorenson Trio" fished public waters. In the morning they hiked in to fish the Rio Chama in the Sargent Wildlife area above the town of Chama, and in the afternoon they fished the Rio Chama below the Heron Lake dam spillway. They also had a good day of fishing.

On day 3 it was the "Sorenson Trio's" turn to fish the Conejos but when they arrived they found that it was unfishable from all the rain the night before as was the Navajo river where we fished on day 1. So after a brief check on the Brazos they went back to fish the Rio Chama below the Heron Lake dam spillway again but hiked further in than they had on day 2. The "Other Group" fished the public waters on the Rio Brazos for most of the day and had pretty good luck. After leaving the Brazos we went to the Rio Chama

and tried to fish some of the public access but there just wasn't enough water in the river to make it worthwhile.

We never tarried long on the water in the late afternoon. We usually stopped fishing about 5pm each day, for one thing we were usually tired by then but also because we were anxious to see what

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880), Tom Wobbe (575-522-5437), Donna Mabie (575-522-3810) in Las Cruces and the Sportsman's Elite fly shop (915-587-4867) in El Paso. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for out of town guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
