## President's Corner

David Carmichael



It is only early June, but we seem to be well on our way to a warm summer; temperatures have already reached the upper 90s here in El Paso, and the mountains are beckoning us to come enjoy the cooler temperatures, cold water and hungry trout. My daughter and I made a quick trip to the club lease on the Rio Peñasco last week. Even though we didn't get on the water until noon, we still had a decent day, catching seven nice trout, including my daughter's 21 ½ inch male brown and my 18" female rainbow. Club member Frances Curtis fished the Mulcock Ranch at about the same time, and her results were similar to ours. She was consistently catching trout; not large numbers, but some large fish, including a nice 18" rainbow she lured out of the grass. The aquatic vegetation is pretty thick in many places, and the trick is to find holes and runs that are deep enough to hold the fish given the clarity of the water, but which have gaps or channels in the vegetation that allow for the presentation of our flies. All of the fish we caught on both leases were on either a San Juan worm pattern or streamers, even though there was an afternoon mayfly hatch in progress during our visit. In other words, the larger food offerings were necessary to coax the fish out of the thick vegetation and/or deep water. Hopefully the trout will turn on to grasshoppers pretty soon; we saw lots of small ones along the banks, but didn't have any patterns that small to throw at the trout. There are lots of chubs on the club lease; we even saw a group of more than 60 chubs swimming together at the tail out of the slow, weedy section above the lower bridge. The club will hopefully be stocking about 250 trout later this month, so the

fishing action should pick up in June and July. Watch your email for the chance to help with the stocking.

I'd like to remind everyone about two opportunities we have to make land managers aware of our concerns and desires regarding the management of our fisheries and public lands. As noted in last month's newsletter, the 2016 Statewide Fisheries Management Plan is available for review on the MNDGF website. Send comments to Laurence D'Alessandro, and if you forward a copy to me, I'll include them in the official club response. Matt Schultz has also invited club members and other members of the public to participate in the upcoming Gila National Forest Plan meeting in Las Cruces on Friday, June 16 at the Farm and Ranch Museum. Further details are presented elsewhere in the newsletter.

*If you want one year of prosperity, plant grain. If you want ten years of prosperity, plant trees. If you want 100 years of prosperity, educate people. (Chinese proverb)*

We hear a lot of talk these days about prosperity, especially about making the United States great again. Of course, there are many different ideas about what prosperity is, who deserves to share in it, and how to make that happen. As we head off around the country to enjoy a summer of fishing in various parts of our public lands, I offer the following brief summary of some of the recent actions taken by our new government in the name of prosperity. I invite you to compare these actions with the conditions you experience in your travels and recreational activities around the West, and to think about how we might respond to these actions in light of our club's stated mission of promoting education through fly fishing.

In February of this year, only a month into his term, President Trump signed an Executive Order that rescinds the Clean Water Rule which was developed by the EPA to implement the Clean Water Act. When it

was first passed in 1972, the Clean Water Act was intended to apply protections to our rivers, streams and water supplies by preventing the discharge of pollution into the "waters of the United States." For 30 years, the protected waters included wetlands and headwaters which are so vital to the health of our fisheries. In 2002, during the second Bush administration, the legislative intent of the law was circumvented in favor of mining interests, by changing the definition of "waters of the U.S." to mean only those rivers that are large and deep enough to permit commercial transportation. As a result, most of the nation's streams and wetlands were no longer protected, and wetland losses were on the increase for the first time since the 1980s. Between 2004 and 2009, the rate of wetland loss increased by 140 percent over the rate measured between 1998 and 2004. In response, the EPA spent more than a decade developing the Clean Water Rule that would restore protections to some of the streams, wetlands and ponds that had been excluded during the Bush administration. The proposed Clean Water Rule was completed

in 2015, incorporating a scientifically and legally justified definition of "waters of the United States." Recent polls indicate that 70% of our citizens support the rule, but the Trump administration has directed the EPA to rescind the rule and revise it in accordance with former Supreme Court justice Antonin Scalia's minority opinion that wetlands and seasonal streams do not merit protection. Following this approach will re-

move about 60% of U.S. streams and 20 million acres of wetlands from protection. Additionally, it will once again allow mining companies to engage in mountain top mining, and discharging tailings into headwater streams. A group of sportsmen organizations, including the American Fly Fishing Trade Association, Trout Unlimited, and the Theodore Roosevelt Conservation Partnership have prepared a statement supporting the Clean Water Rule. In March, President Trump signed his 19<sup>th</sup> Executive Order which makes it easier for energy companies to drill in our country's national parks (Mother Jones.com, April 12, 2017). Protections against energy extraction in national parks date back to 1978, and they were updated in 2016. There has not been any move to change these protections until now because of strong bipartisan agreement on the wisdom of the protections.

*This issue has been dormant for 40 years because amongst Democrats and Republicans there's a consensus that we shouldn't drill in our national parks. (Athan Manuel, Director of Lands Protection Program, Sierra Club)*

Some of the national parks that are high on the list for drilling include Aztec Ruins, Chaco Canyon and Carlsbad Caverns in New Mexico; Glen Canyon, AZ; and Grand Teton in Wyoming.

In May the Trump administration settled a lawsuit with Northern Dynasty Minerals, the company that would like to build the Pebble Mine in the Bristol Bay watershed in Alaska. The Bristol Bay watershed supports the largest sockeye salmon run in the world, providing many jobs in commercial and sport fishing, as well as subsistence fishing for many Native Americans and other Alaskan citizens. After more than a decade of research, the EPA in 2014 determined that the Bristol Bay watershed should be off limits to mining. Northern Dynasty Minerals sued the EPA, and now that the government has settled the lawsuit, the company will be allowed to restart the permitting process. In fact, a company official has said that he is expecting an expedited permitting process from the Trump administration, allowing them to complete the process in record time (Alaska Dispatch News, May 12, 2017). As you can imagine, sportsmen's groups and Native Alaskans are very upset about the reversal of the EPA actions. If fishing in Bristol Bay for sockeye salmon and rainbow trout has been on your bucket list, as it has been on mine, it might be a good idea to make that trip in the next 2½ to 4 years.

Last but not least, the word is today that our President plans to carry out his threats to withdraw from the Paris Accord, in a monumental act of denial of climate change. Most of the people in our country, almost all the countries in the world, and nearly all climate scientists know that global climate change is real, but we will be abrogating our world leadership role in order to assist the oil and gas industry for a little longer? As fly anglers, we see the impact of warming on our fisheries up close and personal. Wildfire frequency has increased 400% since 1970, resulting in increased loss of forests, destabilized slopes, increased runoff, loss of aquatic insects and the fish populations that depend on them. At the same time we are experiencing more intense rain storms, reduced snow pack and more flooding, which also adversely affect our fisheries. So, as we are travelling around this summer looking for good fishing and enjoying our public lands, let's keep track of the problems we see and how they affect us, our fisheries, and the tourism dollars that our sport generates. Then we might think about contacting our elected officials to tell them about the bounty of the West that is under assault, and suggest ways that they could represent our interests so our lands will support prosperity for another 100 years rather than providing wealth for just another year or decade. ▲

## MVFF Board Meeting Minutes

Monday, May 15, 2017

The MVFF Board meeting was called to order by David Carmichael at 7:00pm in the NMDG&F Conference room. Board members present were: Jeff Arterburn (Secretary), David Carmichael (President), Tom Johnson (Vice President), Gary Mann (Treasurer) and Bob Silver. Members absent were: Evan Claassen, Dennis Lanpher, Chuck Mueller and Will Lubenau. Non-Board members in attendance were: Ron Bellerose, Jim Hulsey and Tom Wobbe.

1. **Meeting Minutes.** The minutes from the April 17, 2017 Board meeting were approved as published in the May 2017 issue of the newsletter.
2. **Treasurer's Report.** The Treasurer's report and current account balance statement of \$13,662 was presented by Gary Mann, and accepted by the Board.
3. **Membership Report.** Tom Wobbe reported the membership of updated database through this year: 152 (total past due is 166).
4. **Project Healing Waters.** Ron Bellerose reported he will be at the VFW in Cloudcroft for Fly Tying on Wed 5/17 afternoon-evening, then Cloud Country Pond for fishing Thurs 5/18 afternoon-needs volunteers and will send out a call. Counseling Las Cruces is planning a camping trip inclusive of PHW. Ray will be leading the Fly Tying session next Wed 5/24 at NMDGF. Ron will be planning another San Juan trip.
5. **Gila/Rio Grande chapter of Trout Unlimited.**
  - Jeff Arterburn reported that a Community Open House will be held in Lincoln, NM to discuss developing plans for the Rio Bonito Restoration and Trout Fishery Project that is beginning the design process. The Meeting will be held Thursday May 18, 2017 from 6-8pm in the Lincoln Visitor Center.
  - Saturday June 3<sup>rd</sup> is a free fishing day and we've been asked again to help out hosting booths at these events:
    - a. **The Aldo Leopold Kid's Fishing Derby, Lake Roberts** Saturday June 3rd. Jeff will coordinate this group's booth.

- b. **The 23<sup>rd</sup> Annual Youth Fishing Day, Grindstone Reservoir** Saturday June 3rd. Ron will coordinate this group's booth.
- c. We could use members help with these events and welcome ideas for fun activities.
- GRG-TU is developing a proposal for the NMDGF Share with Wildlife program (SWW) for construction of beaver dam analogue structures for habitat restoration on willow Creek. The due date is Friday June 2<sup>nd</sup>.
- GRG-TU is developing a Proposal for the Western Native Trout Initiative (WNTI) Small Grants Program for design and installation of information signs at Willow Creek. The due date is Thursday June 15. Matching funds are required, and the MVFF board authorized commitment of \$250 if the grant is funded. Members are encouraged to visit the WNTI website and check out the "Know your Natives" program that now features Gila Trout: [www.westernnativetROUT.org/gila-trout](http://www.westernnativetROUT.org/gila-trout)
6. **Web Page Issues:** Bob and Tom brought new information for the ongoing discussion of modifying the process for payments and purchases of MVFF memberships, permits, etc. to make it possible to use PayPal. The goal would be to initiate this option for memberships, and then extend to permit sales as the next stage if working well. Gary expressed vigorous opposition to implementing an on line payment system, concerned that this would require additional reconciliation. His position is that the current system is simple and manageable, and is concerned that the time commitment would exceed that afforded by available volunteers. With some board members expressing frustration, the issue was tabled. David reported receiving a domain name registration email that apparently was a scam trying to extort payment. Jim Hulsey reported that our domain registration was recently renewed through 2018.
7. **American Fisheries Society: Friends of Willow Creek (Gila National Forest)** Buy a shirt to help restore Willow Creek, Gila National Forest, New

Mexico <https://www.booster.com/friends-of-willow-creek>. This fund-raiser is being sponsored by a student chapter of The Wildlife Society, which is the professional organization for wildlife biologists. The students have organized this project and fundraiser to purchase supplies necessary to do the hands-on restoration work on Willow Creek. This group, along with a student chapter of the American Fisheries Society, is planning 2 work events during the 2017 season. The goal for this fundraiser is \$500, which will cover most of the necessary supplies for the project. The t-shirt was designed by Cherry Matchus and features willow leaves. The MVFF board authorized a contribution of \$200.

8. **General Meeting Speakers/Presentations.** The September meeting featuring recent fly fishing trips to New Zealand by members Mary Hoffman, Jim Sorensen, George Sanders and Cheryl Chandler. Open suggestions are requested for the Fall meetings and Banquet in January 2018. David suggested a fishing photographer and guide, and will pursue discussion as a potential banquet speaker.

9. **Club Fishing Trips.**

- Bob Silver is organizing a camping trip to the Conejos, June 30-July 2nd, 2017. The group will be camping at Mogote Campground. For more information or questions contact: [rsilver@nmsu.edu](mailto:rsilver@nmsu.edu).
- Evan Claassen is organizing a trip to the Gila that will target fishing for smallmouth bass.
- Chuck Mueller has scheduled a trip to the San Juan Nov 5-8, 2017.

10. **Other Business:**

- Gary presented an idea for organizing monthly trips for club members to fish the Rio Peñasco, with MVFF-sponsored rental of a transport van and fuel, estimated cost: \$450 + ~\$70 gas cost. Gary will organize communication to club members and coordinate the first event for a date in September.
- The board recommended stocking the Rio Peñasco lease. Bob Silver will contact W. Parker and arrange for stocking with 250 fish.



- Jeff presented a draft proposal to the Western Native Trout Initiative Small Grants Program that will request funding for an informational sign installation focusing on Gila Trout and ongoing habitat restoration at Willow Creek, Catron County, NM. These proposals require matching funds, and several groups are contributing funds for the design and installation costs, and will have their club logo's displayed on the signs. The MVFF board authorized commitment of \$250 support (if the grant is funded).
- Jeff presented information about a fundraiser organized by the NMSU Student Chapter of the American Fisheries Society and Wilder ness Society for the goal of purchasing sup plies and tools for restoration work on Willow Creek. The MVFF board authorized a \$200 contribution.

11. **Other News & Events:**

- The proposed NM angling regulation changes comment portal on the NMDGF website is under development and expected to be open the first week of June. Members are encouraged to respond and comments don't have to be extensive, this is a good way to express interest in angling to NMDGF. David will try to collate comments received through June to write an MVFF response. There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



## Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880), Tom Wobbe (575-522-5437) and Donna Mabie (575-522-3810) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page ([mvff.org](http://mvff.org)) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for guests.

### Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
