#### **President's Corner**



The New Mexico Trout Conclave was held in Albuquerque on March 22. The featured speakers were Ed Engle and Tom Knopick. Ed has retired from guiding to spend more time writing and

speaking. He has a new fly fishing blog on his website, edengleflyfishing.com. Tom is one of the owners of Duranglers Fly Shop in Durango. presentations included a description of the waters where they guide in Southwestern Colorado and a great explanation of the factors that determine how much water is released from the Navajo Reservoir. In a nutshell, there are two endangered species, the Razorback Sucker and the Pikeminnow, in the San Juan River in Arizona. Federal authorities are trying to keep the flow in the San Juan in Arizona at a minimum of 550 cfs. So, depending on the flow from the Animas River and other tributaries, they adjust the flow out of the San Juan reservoir to try to maintain that minimum. Because of the prolonged drought, they are also trying to accumulate water in order to meet the annual allotment of 370,000 acre feet owed to the Navajo Nation, as well as that owed to other water rights owners. In short, don't expect the flow in the San Juan Special Trout Waters to increase much above the current 260 cfs level in the near future.

Van Beacham and Bob Widgren have set the dates for their fly fishing school at the Trinchera Ranch near Ft. Morgan, CO for July 25-27. They hope to have a second class in August, but the exact dates haven't been set. Class size is limited, so if you are interested, check it out at the solitary angler.com.

For specific times and places, look for Tom Wobbe's email, check the Club's website or email me at President@MVFF.org. April is also the time to renew fishing licenses and club dues.


Note that the campsite for the July club trip to the Conejos has been changed to the Mogote Campground.

#### **Bio for Jeff Powell**

Jeff Powell has served for 3 years as the project leader at Mora National Fish Hatchery. Under his direction, Mora NFH has expanded to include all the genetic representations for the Gila trout species. The Main Diamond and South Diamond Gila trout lineages have historically been reared at the facility and now the addition of Spruce Creek, Whiskey Creek and Iron Creek have been added. Gila trout survival rates have dramatically improved at the facility and emphasis on Naturalistic Rearing and Poly-Culture has become the focus of the program. Mora NFH strives to produce quality fish that are genetically appropriate and well prepared for the rigors of the wild.

Previously he spent 7 years at Gavins Point National Fish hatchery, serving different roles: acting project leader, assistant project leader and fish biologist. The focus at Gavins Point NFH was pallid sturgeon, paddle fish and 8 different species of cool and warm water fish. He has also worked at Bozeman Fish Technology Center and Miles City State Fish Hatchery,

in Montana. Jeff holds a Bachelor Degree in Fish and Wildlife Management from Montana State University and is currently working towards a Master degree in Public Administration from San Diego State University, in California.

## **Casting For Recovery**

Casting for Recovery (CFR) is a national, non-profit program that provides an opportunity for women who

have experienced breast cancer to learn to fly fish. During a weekend retreat, women learn to fish in a natural setting where instruction, food and lodging and equipment are provided at no cost. The next CFR program for southern Colorado, New Mexico and west Texas will be held on October 3-5, 2014, at the Philmont Scout Ranch Cimarron, near Participants will stay at the Villa Philmonte complex and will fish the private waters of the ranch. Participants will learn the fundamentals of casting, entomology, knot-tying and equipment basics and will spend time on the water practicing catch-andrelease fishing. CFR is looking for participants from southern NM and west Texas for the 2014 program. Participants are selected at random from all eligible applicants and the deadline for receipt of applications is July 25, 2014. For more information visit www.castingforrecovery.org. There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



#### **Lease Information**

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880), Tom Wobbe (575-522-5437) and Donna Mabie (575-522-3810) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for out of town guests.

#### Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
