Project Healing Waters Fly Fishing is Fly-fishing therapy for wounded vets. Regardless of how you may feel about the wars in Afghanistan and Iraq, it seemed to me to be an opportunity to support the troops.

Four members of MVFF, Chris Evey, Randall Vallee, Jim Hulsey and myself made the trip to Ft. Bliss today (10 July) to conduct a fly tying class for a group of young men. Chris Evey and Randall Vallee have been working tirelessly to put this program together and seek the contribution of vises and supplies from Sportsman's Warehouse.

I must say that I personally was apprehensive about doing this program even though I could see the need. I had several projects I was working on around the house, that seem to be taking some of my time. This morning when it was raining at 6:00 AM I questioned, do I really want to go to El Paso today? #### **Rio Peñasco Fishing Permits**

The Board has recently held discussions on the procedures to be followed when fishing the Rio Peñasco lease. One slight change is to ask that instead of carrying the bottom portion of the permit on their person each fisherman place them on the dashboard of their vehicle so as to be visible through the windshield. Since it may be hard to read the name on the permit the club is issuing new parking passes which will also be placed on the dashboard and should be quite legible. This will allow the ranch manager to see who is on the stream if he didn't see them arrive and will also allow other MVFF members to see who else is fishing in case they want to hunt them down and inquire as to the hot fly of the day. Of course everyone should continue to wear their name tags.

#### **Testing the Waters**

Fish and Game project shows king salmon returning to road system streams

It takes time to produce an enhanced return of king salmon, but eventually anglers will enjoy more diverse sport fishing opportunities on the Kodiak road system. The king salmon enhancement project, started by the Alaska Department of Fish and Game in 2000, aims to dramatically increase the number of adult king salmon in the area.

Len Schwarz, a sport fish area biologist with Fish and Game, said the project involves holding and feeding king smolt, raised from local brood stock, for two weeks before releasing them so they know where to return as adults. Schwarz said after the smolt are released they travel to sea, where they rear and grow for one to five years before returning as adult king salmon. Approximately 75 percent of the fish released stay at sea for three to four years before returning as adults. An average of about 1.5 percent of the smolt released will survive and return.

Schwarz's enthusiasm for the project is evident. "It's the funnest thing I've been involved in my 32 years here," he said. "We're trying to create fishing opportunities for people in Kodiak."

Since the inception of the project, the number of smolt released has risen each year from an initial release of 11,000, Schwarz said. This year, Fish and Game plans to release approximately 148,000 king smolt: 44,000 in the American River, 44,000 in the Olds River and 60,000 in Monashka Creek. Schwarz said that he expects as many as 2,000 king salmon to return annually by 2011. "And people will catch them. It'll be fun. You're going to get a lot of fish," Schwarz said, adding that the salmon return larger than expected. "Fish that have been at sea for four years are coming back at 25 pounds," he said. "It's a lot bigger." All of the returning fish are intended for harvest, with the exception of 60 spawning pairs used as hatchery brood stock, Schwarz said.

Fish and Game currently has an annual operating budget of \$66,400 for the enhancement project, all of which is generated by the sale of sport fishing licenses and king salmon stamps. "When you get your sport fishing license, what do you get back?" Schwarz said. "We try to create opportunities in Kodiak."

Since 2004, Fish and Game has had a cooperative agreement with the Kodiak Regional Aquaculture Association, in which Fish and Game pays KRAA to produce king salmon smolt. In 2007, KRAA and the Lions Club sponsored the Kodiak Peace Cup king salmon sport fishing tournament. Money collected from sponsors and tickets sales was split between prizes and a donation to KRAA to further the current king salmon stocking program. In 2007, a \$9,500 donation was made to KRAA. Results of the 2008 tournament were announced at an awards ceremony Monday night. Judy Kidder of the Lions Club said this year's donation to KRAA is expected to be about \$16,000.

Kidder said Billy Boyce of Sammamish, Wash., who reeled in a 65.4 pound king salmon near Old Harbor, took home this year's top prize of \$11,148.

Schwarz said Fish and Game has kept the enhancement project "low profile" for years because of the inherent time and waiting involved. As results from the relatively small initial releases begin to show, it's a good time to let people know, he said. "It's a real good project, but you've got to be patient," Schwarz said. "It takes three to four years to see results. Now I want people to know."

Schwarz said Fish and Game has no plans to expand the project beyond its current numbers, but it will continue to operate at the level it is now. "We're about as big as we're going to get," he said. "We're going to keep doing what we're doing, and hopefully get some big numbers in the years to come."

#### **MVFF Board Meeting Minutes**

Monday, July 14, 2008

The MVFF Board meeting was called to order at 7:00pm in the NMDG&F conference room by Tom Wobbe presiding in the absence of Paul Turner.

In Attendance: Tom Wobbe, Jim Hulsey, Ron Bellerose, Randall and Vicki Vallee, Jeff Arterburn, George Sanders, Richard Keding, Donna Mabie, Blaine Goss, Gary Mann and Richard Newton. Absent: Paul Turner and Robert Silver.

- Minutes of the June Board Meeting were approved as published in the July newsletter.
- 2. The Treasurer's Report given by Gary Mann was approved.
- Tom Wobbe reported that 152 club members have paid their dues through March of 2009.
   Thirty-one of the members are from out of town.
   Twenty-two members have not paid and will be dropped from the records soon.
- 4. Dashboard cards are ready and their use will be explained in the August newsletter.
- 5. Randall Vallee discussed the Healing Waters flytying session held on July 10<sup>th</sup> at Ft. Bliss. Jim Hulsey and Tom Wobbe were the only volunteers. The participants were divided into two groups totaling 19 of the 26 expected. The flytying lessons went quite well and positive responses were given by the tyers. Since the students had never flyfished, the lessons were kept quite

simple. For the next session the students will go in a van provided by the military to a nearby fishing spot to learn casting. Randall will check on the exact date, now tentatively set for 14 August. He said that at least six club volunteers are needed to help.

- Sportsman's Warehouse is still working on the details in getting Lefty Kreh for an all day workshop. Corporate approval is needed and further Information should be forthcoming soon.
- 7. Tom Wobbe will check into sending about 75 solicitations for raffle prize donations.
- 8. The *Women in Sports* project in El Paso has had no positive responses or action taken.
- The club is still searching for guides for the members at the San Juan River outing in October. John Tavenner is trying to arrange guides for the outing.
- 10. Four signs, about 18" X 22", will be posted in the coming weeks along the leased waters. These signs will caution people that club permits and MVFF membership are required to fish these waters.
- 11. George Sanders mentioned that the Green and Gunnison Rivers had five to 10 times higher flows than usual.

The meeting was adjourned at 8:30 p.m.



### **Fishing Reports**

Blaine Goss and Dick Newton fished the lease on 25 July which was after the big flood that was experienced in early July. They confined all of their fishing to the lower stretches of the stream, i.e. the parts above and below the lower bridge. They caught numerous fish, the largest being 16-inches and several 14-inchers. The patterns of choice were terrestrials, especially grasshopper patterns.

The high water in early July rendered the lower bridge unusable and washed out the water diversion gate below the bridge so all of the water is now staying in the stream. It also cleaned out much of the grass that was clogging many stretches of the stream.

Blaine reported the stream to be somewhat murky but quite fishable.

Its nice to know that the fish are still there in spite of the earlier floods. If you haven't fished the lease this summer, now is the time to go.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



#### **Lease Information**

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from any of the Club Officers or Board Members and are also available at the *Angler's Nook* (575-522-3810) in Las Cruces and the ATF fly shop in El Paso (915-225-0570.) Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for out of town guests.

#### **Directions to the Lease:**

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
