President's Corner

Bob Silver is my fishing guru! On July 9, my brother, his friend and I met Bob and two of his friends at Mogote Campground for the Club trip to the Conejos. On Friday, we fished the Meadows section of the Conejos where the stream flow was around 370 cfs. Bob kept saying to add weight until you either catch fish or hang up on the bottom. So I added weight and added weight, until I had seven bee bees in my Toobie and finally started to dredge some of the big fat Browns out of the deeper holes.

The next day, we all went to Osier station on the Cumbres and Toltec steam railroad to fish the Rio de Los Pinos. I had always walked down the railroad's right of way to an old roadbed that leads down to the river, but Bob said to work my way down to the river sooner. So I dutifully bushwhacked down the canyon wall. After slipping and sliding down the descent to the bottom, sure enough there was a nice long stretch of river with deep pools and long runs and riffles. This stretch of the river obviously doesn't get much pressure because there was no shortage of 14 to 20 inch Browns that were eager to eat a dry fly. In the afternoon, the wind came up, blowing any hatch off of the water and making any cast difficult at best. Bob and his friends went to Osier Creek to catch some Rio Grande cutts and we went back to camp to practice our 12 ounce curls.

As it turned out, we were too early for the Green Drake hatch on the Meadows section of the Conejos on that trip. But Mary and I went back about two weeks later and the hatch was in full swing. By that time, the stream flow was down to 108 cfs. We started fishing about 9:30am and, within 30 minutes, the fish were moving into the shallower, flat areas of the river and gulping the insects off of the top of the water. We had started fishing with a foam body Green Drake dry fly and a red annelid dropper. Before the hatch started, we caught a few on the dropper. After the hatch, however, the fish were concentrating on the dry fly to the point that we just took the dropper off because it was simply in the way. For a little over two hours, we caught fish as fast as we could cast,

hook the fish, land it and get it off. Then, as fast as the hatch started, it was over. We dredged a couple more out of a deep hole with a double nymph rig and decided to call it a day—but what a day!

Unlike recent years, the spring runoff has lasted into July but has finally subsided. Late spring snow and abundant rains through the summer has kept the grass high, the forests healthy and the streams full in northern New Mexico and southern Colorado. Next month, we will resume our regular monthly meetings and Liars and Tiers. The Board meets at 7:00 pm on Monday, August 17th to plan the fall agenda. If you have any ideas or suggestions, please email me at president@mvff.org or come to the Board meeting. All Board meetings are open to members. In the meantime, we are just getting into the prime fishing season so get out there and fish.

Willow Creek Gila Trout Survey Results



June 26 – 27, 2015 Jeff Arterburn

A fish sampling survey of Willow Creek and Little Turkey Creek by electrofishing was conducted in late June. This section of stream was hit

hard by the 2012 fire and subsequent ash flows. Recovery efforts include installation of a temporary fish barrier near the junction with Gilita Creek that will be replaced by a permanent barrier in the future, repeated stocking with South Diamond Gila Trout, and physical removal of non-native trout. This area is

open to fishing with special regulations, and is currently the most accessible place in New Mexico to catch a Gila Trout.

The crew also sampled the small tributary, Little Turkey Creek, which now flows through shallow riffles and pools ~0.5 cfs, which suffers from a scoured stream channel, unstable and incised stream banks and lacks riparian canopy and other woody vegetation.

In total 59 Gila Trout were netted, including several beautiful brood stock fish in the 13–18" range. Other native species netted include Speckled Dace (1,684), Desert Sucker (8) and Sonora Sucker (1) and one angry beaver! The good news is that no non-native Brown Trout were collected.

With the monsoon rains a planned second sampling in July was canceled, but there is a lot of opportunity for future stream restoration and habitat work projects that will enhance this area for continuing improvement and recreational fishing for Gila Trout.

Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575–524–1880), Tom Wobbe (575–522–5437) and Donna Mabie (575–522–3810) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575–687–3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one–day, one–time permit for guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
