We started the month off by helping Ti Piper with a fishing clinic at the Alumni Pond for over 150 enthusiastic special needs children. This was a very rewarding event putting smiles

on everyone's faces. So, thanks to all who volunteered.

On November 5th we had 15 volunteers at the Lease to help with the stocking of 550 rainbows and with the placement of some giant rocks in specific locations of the stream to improve habitat. Afterwards we had a nice shore lunch with some Alaskan salmon that was given to us by Howard Steinhoff. I want to thank all of the members for doing an excellent job. Early next year we are planning to do more restoration on the lower section of the river and will be looking for volunteers to help with that project. # **Unsticking Fly Rod Ferrules**

A couple of weeks ago five of us went to the lease on a Thursday. It started as an all-around special day. The best part was being able to take the day off from work....hoorah! And the fish cooperated and the weather was

nice.

I was fishing with my 3-weight Winston LT rod. This is the Presidents' rod that the Club gave me at the Annual Banquet in 2010. I really love fishing this rod. The day that started so well became a worry because I could not get the rod apart. No matter what I did, not one of ferrules would come loose. I really tried everything I knew, but they were really stuck. So before I could make the situation go from bad to worse, I took the rod home in one piece. I was hoping that I remembered to mail the warranty card back to Winston just in case. I am glad Jim Hulsey drove his extended Ford Expedition that day too.

At home, I consulted the "all knowing" Internet for advice. What I found out really worked and I wanted to share that in case this happens to you someday. Here are few things you should not do. DO NOT forcefully twist the rod, use pliers, vice grips, bench vices or any other mechanical equipment to hold the rod. Under NO circumstances should you use the guides to get a better grip on the rod unless you plan on replacing the guide when it comes loose. The suggestions ran from using penetrating oil to heating the ferrules with a hair drier. I could see that some ideas might lead to damaging the rod in some way.

Since my fall back plan was to send the rod back to Winston in one piece, I didn't want to do something

that would jeopardize the warranty. So I based my decision on what to try at home on two things. The first was to consider the apparent reputation of the source of information. For example, advice by fly shops and guides ranked higher in my decision making than advice from "Joe Six-Pack". And second, I followed the "do no harm" principle in case Winston was my only hope. The solution I tried worked so well, I could hardly believe the rod was stuck at all. I wound up chilling each ferrule connection.

At my house the kitchen countertop sometimes becomes an extension of my workshop to my wife's dismay, but this time Gail was sympathetic to my plight (and I needed the extra space and the rod was much cleaner than other things I sometimes drag in). I put a towel down on the kitchen countertop and sandwiched each ferrule between two packets of blue ice. A baggie with regular ice would work too. I waited about 15 or 20-minutes and then I just pulled each segment apart. They all came apart so easily that I could hardly believe they were immovable before. To keep this from happening again, I cleaned both ends of the ferrules and applied a small coating of rod ferrule wax. The Winston LT uses spigot ferrules.

I will be more careful not to push them together too tightly next time. But if this happens to you make sure you go with someone with a long wheel base vehicle or have some ice handy. Two cans of cold beer would work too and you can toast your success afterwards.

# **Fishing Report**

On November 10th the day was sunny and mild. The temperature was about 40 when we arrived at the Lease and eventually warmed up to 60. About 9:30am, a blue wing olive hatch lasted intermittently through the morning. Some fish were looking "up" and I caught a couple of fish at the lower bridge on a size 20 Adams

parachute. My best flies were a size 16 Hares Ear

with a gold bead and a size 18 Lightning Bug with a silver bead. Here is a picture of the Lightning Bug, but the one I used had peacock hurl instead of the red material shown in the picture.



I fished the hares ear and the bug below a small strike indicator set about 3 feet above the bottom fly. The newly released stockers are doing well and hungry. I caught two fish on one cast....that is a first. Everyone caught fish. The newly placed rocks look good. Three browns were caught and two were about 15 or so inches long. We stocked the Lease on November 5th because of concern that ash from the Mayhill fire may have killed some fish from a runoff in late summer. But, I am happy that many fish survived including a very large rainbow in the lower end of the slough. I hooked it on the bug, but it jumped once too often and broke the tippet before I could land it.

Yes, I can hear it now. I know what you are saying.....but, I do have a witness. Even though it wasn't landed for a picture, it is nice to know that we do have some big fish at the lease. I like Henry David Thoreau's quote - "Many men go fishing all of their lives without knowing that it is not fish they are after."

If you see me at the lease, I bet you can guess where I will be fishing.

# **MVFF Board Meeting Minutes**

Monday, November 21, 2011 Submitted by Jim Sorenson, Secretary

The MVFF Board meeting was called to order at 7:00pm in the NMDG&F conference room by President Chuck Mueller. In attendance were Chuck Mueller, Jeff Arteburn, Ron Warnke, Gary Mann, Bob Silver, Jim Sorenson and Ron Bellerose and non-Board members, Tom Wobbe and Jim Hulsey.

- 1. Minutes of the October 2011 Board meeting were approved as published in the newsletter.
- 2. The Treasurer reported that the Club has a balance of \$8,040 in the bank after spending \$2,017 for raffle prizes for the annual banquet and \$1,695 for stream improvements at the Lease. The Treasurer's Report was accepted.
- Tom Wobbe reported that the Club has 195 paid members. Between November 2010 and October 2011, 253 permits for the Lease were sold.
- 4. Ron Bellerose reported that Ft. Bliss is shortening its PTSD treatment program to six weeks. It is not clear whether it will be able to continue to participate in the Project Healing Waters Program. He has not received a response for WSMR, but has had a good response from the local VA clinic. He will talk to the local Toyota dealer about sponsoring an informational program for veterans in conjunction with the recent large donation to

- PHW by Toyota. He has submitted a budget of \$2,000 to PHW.
- Ron Warnke reported that two hats were sold and 14 remain.
- Noah Parker will give a presentation on a guided fly fishing trip in the Chama area at the December general meeting. Details regarding the trip were distributed to the Board.
- 8. There was a brief discussion regarding the topic for Bob Widgren's presentation at the annual banquet.
- A motion was approved to sell 11 permits for the price of ten (i.e., anyone purchasing 10 lease permits would receive an additional free permit).
   The Club will absorb the cost of the free permit.
- Work to extend the stream improvements in February 2012 will be scheduled.
- 11. A motion was approved to allow Bob Silver to purchase a copy of Zedeke's book on stream improvements for the Club.
- Jim Sorenson will contact Van Beacham about being the speaker at the February general meeting.
- 13. The next Board meeting will be Monday, December 19 at 7:00pm.

The meeting was adjourned at 8:30pm.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



#### Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880), Tom Wobbe (575-522-5437), Donna Mabie (575-522-3810) in Las Cruces and the Sportsman's Elite fly shop (915-587-4867) in El Paso. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for out of town guests.

#### **Directions to the Lease:**

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
