MVFF Board Meeting Minutes

Monday, May 19, 2008

The MVFF Board meeting was called to order at 7:00pm in the NMDG&F conference room.

In Attendance: Ron Bellerose, Richard Newton, Jeff Arterburn, Jim Hulsey, Gary Mann, Blaine Goss, Randall and Vicki Vallee, Richard Keding, and Donna Mabie. Absent: Paul Turner, George Sanders, and Bob Silver.

- Minutes of the April Board Meeting were approved as published in the May newsletter as well as the Treasurer's Report presented by Gary Mann.
- 2. A sign-up sheet was passed around for the June 7th fishing clinic.
- Randall Vallee explained that Chris Evey would be gone a lot this summer and so he would go to Ft.
 Bliss himself for the Healing Waters Project. Tom Wobbe will send out e-mails soliciting volunteers to help on this project.
- 4. The San Juan club trip is planned for October 17, 18, and 19. It was agreed that there will be a general meeting September 8th to discuss this trip and the Alaska trips. There will be no speaker for the month of September. The picnic will be held probably September 13th. Bob Silver will make the arrangements with NMSU to reserve the park.
- The last newsletter asked for volunteers for the board member vacancy. Blaine Goss was voted as the new board member replacement for Jeremiah Richardson who has resigned.
- 6. Rio Peñasco fishing reports have been quite positive. The new signs and dashboard cards for the lease are still being worked out. Paul Turner has suggested that members report size ratio of their catch from the lease to provide data that would help determine future stocking efforts. The feasibility of this request and concerns for validity of the resulting data were discussed. The

- board encourages members to submit fishing reports, and recognizes some qualitative value of data of this type. Members are encouraged to respond according to their interests.
- 7. The rod building sessions are coming along well. Bob Silver is the instructor. There are 12 students.
- It was agreed that the Liars and Tiers will not meet from June through August. It will be started again in September if enough people show interest in attending.
- 9. Initial planning for the Annual Banquet in January was discussed. Gary Mann is working with Joseph from Sportsman's Warehouse to possibly engage a high visibility speaker from the National fly fishing community. The date of January 24th, 2009 was identified as a possibility.
- 10. Randall Vallee initiated discussion of a recent advertisement by the Southwest Consolidated Sportsmen in the Las Cruces Sun News in which the MVFF was identified as a supporting organization. The board was concerned that no formal request of support from this group was received. The board members reiterated the consensus opinion to encourage individual action from the MVFF members, but that no individual member can authorize a supporting signature representing the organization. The board will distribute information on efforts that impact fly fishing and water quality related subjects, and will responsibly deal with formal requests for MVFF support.
- 11. The next MVFF Board meeting will be held June 16th at the regular time and place.

The meeting was adjourned at 8:03 p.m.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from any of the Club Officers or Board Members and are also available at the *Angler's Nook* (575-522-3810) in Las Cruces and the ATF fly shop in El Paso (915-225-0570.) Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for out of town guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
