President's Corner



David Carmichael

I am pleased to report that the MVFF club has dipped its collective toes into the waters of online membership services. After months of discussion in our board meetings, we now have a new Pay-Pal account that will allow mem-

bers to renew their memberships and pay for fishing permits online. I want to thank board members Tom Johnson, Jim Hulsey, and Bob Silver for their efforts in setting up and testing the new account. It is anticipated that the PayPal account will eventually allow members to directly purchase other items such as tickets to the Fly Fishing Film Tour event and club merchandise. We currently have about 210 paid members, and membership renewals are due this month, so we hope the PayPal system will make it easier for everyone to submit their dues and speed up the process of getting fishing permits to out of town members.

The winds of spring are already here, albeit a month ahead of schedule, so it must be time to start thinking about and preparing for our summer fishing adventures. Over the past several months I've received several requests from the Lady Anglers and other club members to arrange for a casting class taught by a certified casting instructor. In response, we have arranged to have Bob Widgren drive down from Albuquerque, teach a couple of casting classes, and make a presentation at our next meeting of the general membership. On Sunday, March 11, Bob will teach two back-to-back casting classes at the Alumni Pond on the NMSU campus. The first class, scheduled for

9am, will be for the Lady Anglers or any other women in the club who would like to improve their casting without a bunch of guys telling them what to do. At about 10:30 there will be another session for all club members. At our club meeting the following day, Monday, March 12, Bob will present a slide show entitled "Fly Casting: Techniques & Troubles." I hope many of you will be able to attend what should be a very useful couple of days of preparation for time on the water later in the season.



An opinion poll taken last year by the Theodore Roosevelt Conservation Partnership, and reported in Outdoor Life (part of the Field & Stream Network) produced some pretty amazing results regarding anglers' and hunters' attitudes about our public lands. One of the most compelling results of the poll is the finding that 94% of anglers and 64% of hunters depend on public lands for at least part of their activities (Ben Long, Outdoor Life, June 29, 2017). The poll respondents weighed in on a number of other issues that are being discussed in government circles, and some of the results may be surprising, especially if one has been listening to claims being made by our elected officials. Ninety-seven percent of the respondents agree that protecting and conserving public lands for future generations is important. Eightyseven percent do not want to see any cuts in the federal budget that would reduce funding for conservation. Eighty percent support the Clean Water Act protections for headwater streams and wetlands, and 77% of Republicans and 80% of Democrats support keeping the existing number and size of National Monuments that offer hunting and fishing opportunities. In other words, support for conservation of our public lands is very strong all across the political spectrum; the political polarization we often see with regard to other public policy issues does not really occur with public lands, and we should not allow our elected officials to pretend that it does.

Increasingly, sportsmen's groups, conservation groups and other public lands stakeholders are rec-

ognizing that we will need to work together to maintain the quality of, and access to our public lands. In the emails I receive as club president, I am seeing evidence of increased efforts to network among public lands user groups. For example, I regularly receive (and forward to the Board members) contacts from groups such as Trout Unlimited, the New Mexico Wildlife Federation, and the New Mexico Backcountry Hunters & Anglers. I recently received a request for assistance from another worthwhile group which is offering some special opportunities for angling and hunting in northern New Mexico.

The Special Forces Association, Chapter 80, Las Cruces, New Mexico is holding two raffles to raise funds for their programs. The prizes consist of an allexpenses paid elk hunting trip and a separate guided fishing trip for 2 people. Lodging and meals will be provided by the NM Lodge & Ranch at Chama Land & Cattle Company. The raffle tickets cost \$20 each for the elk hunt, and \$10 for the guided fishing trip. A maximum of 600 tickets will be sold for each raffle. To purchase tickets it will be necessary to contact the Association by email, request the number of tickets you want to purchase, and send in your payment. 

MVFF Board Meeting Minutes

Monday, February 19, 2018 Submitted by Jeff Arterburn, Secretary

The MVFF Board meeting was called to order by David Carmichael at 7:01pm in the NMDG&F Conference room. Board members present were: Jeff Arterburn (Secretary), David Carmichael (President), Jim Hulsey, Bob Silver (Membership), Chuck Mueller (Treasurer), Dillen Martinez, Jim Sorenson and Tom Johnson (Vice President). Board Members absent: Robert Ardovino. Non-Board members in attendance: Ron Bellerose and Zach Speir (VP NMSU American Fisheries Society.

- Meeting Minutes. The minutes from the January 15, 2018 Board meeting were approved as published in the February 2018 issue of the newsletter.
- Treasurer's Report. The Treasurer's report and current account balance statement of \$10,758.42 was presented by Chuck Mueller, and accepted by the Board.
- 3. **Membership Report**. Bob Silver reported 209 active members, with 7 new members joining since last report.
- 4. **Project Healing Waters**. The program is looking for someone to serve as a new volunteer lead alternate, particularly to help manage the fly tying sessions, fishing trips to the lease, etc. Another notice will be placed in the March newsletter. Fly tying sessions are held the 2nd Tuesday of the month from 10am–12pm, and also on the last Wednesday of the month at the Vet Center. A new clinic will be opening soon. Ron is planning another trip to Silver Creek in AZ March 25–28, and may need an additional volunteer to help out.
- 5. Gila/Rio Grande Chapter of Trout Unlimited. Jeff Arterburn informed the board that the GRG-TU Board Members have started meeting regularly on the 3rd Mondays of the month from 5:30-6:30 pm at the Game II, 4131 Northrise Drive, and anyone interested is welcome to attend. Jeff and Brad attended the recent Gila Recovery Team meeting and can share details. The NMDGF progress on Whitewater Creek is promising and if all proceeds as planned the opportunity for restoring Gila Trout should be starting in 2019. Jeff and Jim Brooks will be presenting at the Gila Natural His-

- tory Symposium on February 23rd. The symposium is held in the Global Resource Center, Western New Mexico University, and the GRG-TU talk is titled "Converging Interests in Conservation and Angling to Engage Citizen Science Support for Restoration of Native Gila Trout". The Chapter has a pending USFS Citizen Science grant proposal requesting support for continuing work on Willow Creek and expects to hear about funding decisions in early March. Design of an informational sign installation at Willow Creek is underway, and planning for a volunteer work weekend has narrowed down to May 11–13.
- 6. **NMSU American Fisheries Students**. Dillen reported that 10 students are planning to participate in the fly tying session held starting 9am, Feb 24th, on the NMSU campus in Knox Hall Room 142. The next day, Sunday Feb 25th, the group will make a trip to the lease. Dillen will have a confirmed final list by Wednesday, and will coordinate with volunteers providing transport to the lease. The carpool will plan to leave Las Cruces at 7am from the old Kmart lot of Hwy 70.
- 7. **Presentations and Events**. Bob Widgren will present specialized casting instruction on Sunday morning March 12th. The specific details need to be finalized, but both the women's angling group and college students have expressed interest in special casting sessions. Bob's presentation at the general meeting on Monday March 13th will address how to recognize and fix casting problems. Ron indicated that he may not be available to pick up the NMDGF conference room key for the meeting and the coffee pot from the storage unit; Jim Hulsey offered to take care of these (if needed).

The April 9th meeting will feature David Carmichael with a presentation on "Why bother keeping a fly fishing journal?" Looking ahead to the May 14th meeting, Tom Johnson suggested a presentation featuring an overview of local areas to fish. Laurence D'Allesandro from NMDGF was suggested as a possible speaker, and will be contacted to see if he is available.

Chuck reported on the rod building class he's offered: so far 2 members have completed their rods, and 4 others have started. He is also beginning to plan for the fall San Juan trip and is focusing on the 1st week in November (Nov 4-7th). Dave has also confirmed Molly Semenik for the January 2019 Banquet. She will also be presenting casting classes, one targeting beginner to intermediate level casters, and another for more advanced fly casters. The banquet program will be covering her new fishing book "25 Best Offthe-Beaten-Path Montana Fly Fishing Streams". David reported on new correspondence from the Las Cruces Special Forces Association that is holding a fundraising raffle for an all expense paid hunting or fishing trip at the NM Lodge & Ranch at Chama Land & Cattle Company. Information on raffle ticket sales will be posted in March Newsletter.

8. **Board & Committee Activities, Needs, and Discussions.** Tom Johnson talked about actions towards setting up the PayPal account. The board agreed that the small extra fees for PayPal transactions

should be added to individual purchase costs. Tom will continue and report back to the board.

- 9. Rio Peñasco Lease. No report.
- 10. **Kids' Fishing Clinic**. Tom Johnson organizing volunteers for Kid's Clinic is scheduled for March 24th 2018. Trout stocking is scheduled, arrangements for bathroom facilities made, and Dillen is working on the NMSU permit for using pond. Volunteers are needed to host 11 stations, an initial sign-up sheet was started and Tom is recruiting participants.
- 11. Other: The Fly Fishing Film Tour 2018 confirmed the club's interest in hosting the event again this year, and will include El Paso/Las Cruces in the list of cities hosting the films. Likely dates in Oct-Nov will be considered.
- 12. The next MVFF Board Meeting is scheduled for March 19th. Chuck will pick up the key.

Meeting was adjourned at 8:45pm. 1

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575–524–1880) or Bob Silver (575–522–6325) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575–687–3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
