President's Corner

Several items of potential interest were discussed at a board meeting of the New Mexico Wildlife Federation that I

attended in Albuquerque on the 7th. The current Director of the New Mexico Department of Game and Fish, Bruce Thompson, has taken another job so the NM Game and Fish Commission will be selecting a new director with input from Diane Denish who would become acting governor if Bill Richardson accepts a position within President-elect Barack Obama's administration. Regardless of your political orientation I think all MVFF members should realize the importance of organizations like the National Wildlife Federation and Trout Unlimited in lobbying for fish and wildlife-related issues at the national and state level. One of the top agenda items for both of these organizations is global climate change and its impact on fish and wildlife populations in North Both presidential candidates had taken America. strong positions on dealing with climate change and the need to increase alternative energy sources. The incoming Congress will be concentrating on improving our economy and making us less dependent on imported oil. Increased drilling for oil and natural gas has benefited New Mexico in many

ways. A positive effect has been the increase in money coming into the state's coffers via severance taxes. However, Trout Unlimited believes the increase in sediment inputs into the San Juan River below Navajo Dam is related to increased drilling in the watershed. There may be a scientific study started soon to evaluate the causes and effects of sedimentation on the trout fishery below the dam.

I represented MVFF at the annual banquet of the Southwest Consolidated Sportsmen in Las Cruces just before our club trip to the San Juan River. About 20 MVFF members participated in the trip and cookout. We had great weather and variable fishing success. My wife and I only fished one day and caught some nice trout, but fishing pressure in Texas Hole and downstream was heavy and catch rates lower for waders than in past years. We had 12 MVFF members take advantage of the guide that was available. He also guides on Navajo Reservoir for flyfishing for smallmouth bass and northern pike so contact me if you might be interested. I talked with a fellow that landed a 23-inch rainbow while floating the quality section. It appears that the high spring and early summer flows in the river improved the health of the trout as they were in good condition and strong fighters. I had a problem breaking off trout until I realized my tippet was too old. It would have saved me quite a few flies and a lot of time if I had thrown it away earlier.

We had a great program at our November 10th membership meeting when Karen Denison discussed a special flyfishing school for women held annually near Creede, Colorado. We also have a trip to the Rio Peñasco scheduled on the 13th with servicemen in the Project Healing Waters program. This has been a rewarding project for MVFF and will be continuing next year. MVFF also has plans to stock the Rio Peñasco with brown and rainbow trout on November 16th so contact me at 575-523-6880 or by email if you can help out. Plans for the annual Awards Banquet on January 17th are shaping up nicely so put that date on your calendar.

HEALING WATERS

Lefty's Deceiver

The center of attention for the Liars and Tyers this month will be *Lefty's Deceiver*.

"The fly can be tied in many ways. The Lefty's Deceiver is not really a strict pattern but a method of tying. It can have various shapes, lengths, and colors. The fly can be tied as short as two inches and longer than a foot for billfish, amberjack, and other species demanding a large offering. It can be tied in a bend-



back fashion or with the hook reversed. It has caught everything from striped bass to baramundi and billfish. To get full benefit from the Lefty's Deceiver, you need to analyze what you are trying to do and match the type of fly to the conditions." - Lefty Kreh

Hook: Mustad 34007 or 34011, #4 to 3/0. Thread: White 6/0 Tail: Six to eight white saltwater saddle hackles tied at hook bend. Flash: Rainbow and/or pearl Krystal Flash trimmed to different lengths--some fibers should extend past saddle hackles. Wing: Two clumps of white bucktail on the sides,

one clump of chartreuse bucktail on top. Throat: Red Flashabou or red Accent Flash. Eyes: Painted on body (optional).

MVFF Board Meeting Minutes

Monday, October 27, 2008

The MVFF Board meeting was called to order at 7:05pm in the NMDG&F conference room with Paul Turner presiding.

In attendance: Paul Turner, Richard Keding, Jim Hulsey, Tom Wobbe, Blaine Goss, Jeff Arterburn, Donna Mabie, Randall Vallee, George Sanders and Gary Mann. Absent: Bob Silver

- 1. Minutes of the September Board Meeting were approved as published in the October newsletter.
- 2. The Treasurer's report presented by Gary Mann was approved. The Report shows the Club to have a balance of \$11,999.
- 3. The Board approved funds for stocking 200 browns (8-10") and 200 rainbows at the lease waters on the Rio Peñasco sometime in November, probably on Sunday, Nov. 16th. At that time, the new signs will be posted, if they haven't been already.
- About 25 members attended the San Juan fishing outing in Oct. and 20 came to the potluck on Friday. Not many fish were caught on this outing.
- 5. Tom Wobbe reported that there are 192 paid members: 78 from Las Cruces, 53 from El Paso, and the rest from elsewhere. Forty have not paid and are not listed in these figures.
- Mike Anderson was the recipient of the Norman J. Mabie scholarship money awarded in April of this year.
- Paul Turner reported there is \$800 plus of habitat money still available which will not expire. Perhaps it could be used to plant trees in March or April.

- Gila Habitat wants the club's help and Paul will know more after the meeting with Matt Shultz on Oct. 29th.
- 9. The NMDG&F cannot waive the fee for fishing licenses for the Healing Waters participants who will be fishing at the lease. Jim Ellett has indicated that he will waive his fee. A cook-out is also planned for that day. Six to eight volunteers will be needed.
- 10. Paul Turner has reserved the facilities at St. Paul's Methodist Church for the club banquet to be held January 17th. This is the same place where the banquet was held last year. Paul will order the same foods as last year from the same person. Gary Mann has lined up Scott Sanchez as the speaker for this banquet. He comes highly recommended. Paul will have to reserve the church facilities for some extra hours during the day before the banquet , perhaps from 10:00 am to 4:00 pm for demonstrations by Scott. Bob Silver and Jeff Arterburn may build a couple of flyfishing rods to be raffled. Perhaps 6/7 wt. Sage or Loomis rods.
- 11. No final decision was made regarding adding \$500 from club funds to the scholarships, in addition to that provided by the Norman J. Mabie scholarship funds.
- 12. More instructions regarding safe handling of the fish at the lease will be forthcoming at the next general meeting.

The meeting was adjourned at 8:45 p.m.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from any of the Club Officers or Board Members and are also available at the *Angler's Nook* (575-522-3810) in Las Cruces and the ATF fly shop in El Paso (915-225-0570.) Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for out of town guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
