President's Corner




David Carmichael Late last month Jeff and Michelle Arterburn and I had the pleasure of attending a celebration at the El Paso Museum of Art for the opening of a new exhibition, "Eldridge Hardie: Art of a Life in Sport." The exhibition includes oil paintings and

watercolors being shown in the Peter and Margaret DeWetter Gallery where they will be on display through March 5, 2017. MVFF club members Donna Curlin and Sam Moore are among the Presenting Sponsors of the exhibition. Thank you both for helping to make the exhibition possible.

The featured work is a wonderful oil painting commissioned by the El Paso Museum of Art Foundation, entitled *Fish Creek Afternoon* (see below). Rumor has it that Sam is the angler depicted in the painting.



Eldridge Hardie grew up hunting and fishing in the El Paso area before moving away to study art at the Washington University School of Fine Art in St. Louis. After college he returned to El Paso where he met Tom Lea, who became one of his mentors and role models. Hardie is a nationally acclaimed wildlife artist who has exhibited at the National Museum of Wildlife Art, the Gilcrease Museum, the C. M. Russell Museum, and the American Museum of Flyfishing. His painting *In Rough Country* (2001) won the Texas Quail Stamp Award in 2002. The exhibition includes two similar paintings depicting details of quail hunts in the rough backcountry of the Southwest.

Hardie's works evoke the sights, sounds and feelings that one actually experiences in the field. But despite being impressionistic, they manage to also focus the viewer's attention on small but significant details that are evident to one who has participated in and ob-

served hunting and fishing for many years: details of quail markings; the muscular definition of well-conditioned hunting dogs; the graceful arc of a fly rod accurately depicted; and the subtle indications of current seams in flowing waters. The exhibition, the first of its kind for the El Paso Museum of Art, contains more than 20 oils, watercolors and sketches spanning several decades of Hardie's long career. It is definitely worth a visit next time you are in the neighborhood.

We had a great turnout for the stocking activity on the lease last month. Thanks to all the club members who helped make short work of releasing 500 trout. That work, in combination with the high, clear flows and cool temperatures the Rio Peñasco is currently experiencing has resulted in some excellent fishing. I had the opportunity to spend 4 ½ hours fishing the lease last weekend, and I had a great time. The fall colors are starting to show and there were flocks of mallards and turkeys at several locations. Perhaps the most unexpected delight was the repeated spectacle of small clouds of yellow and purple butterflies exploding from the muddy banks and swirling around me like snowflakes when I stepped close to the stream.

The air temperature was in the mid-70s, but the water temperature felt significantly cooler than on the day we did the stocking; when I measured with a thermometer, the afternoon water temperature was 60 degrees, just a bit on the chilly side for wet wading. The water was high and extremely clear; perhaps the clearest I've ever seen on the lease. The river bottom was visible in all but the very deepest or most agitated pools. Probably because of the extreme clarity of the water, the fish were hunkered down and challenging to approach. The weeds floating along on the current were an additional challenge, and I had to clean the weeds off my flies and tippet knots about every other cast or so.

Despite the challenges, the fishing was quite good. During the time I spent on the water I caught 19 trout (and missed a couple more) and about half a dozen chubs. Most were stockers, but four were nice hold over rainbows of 15, 16 and 18 inches. The 18 inch female rainbow was especially fun and satisfying to land. She went airborne a few times and I had to "walk the dog" just as Landon Mayer demonstrated in

the video we viewed at the last club meeting. That technique really worked!

The stockers took either RS2 emergers or red copper johns, but all the larger fish were caught on a weighted San Juan worm. Nearly all the trout were caught at the upper end of the lease, above and below the upper bridge, but the largest one was from the lower end of the lease. Grasshoppers were evident all along the river, but I didn't see any trout feeding on them, and the hopper patterns I threw produced no takes. Same goes for the shiny black beetles I saw floating on the water... no trout feeding on them. One other detail was very important in locating feeding trout. All of the trout were caught in portions of the stream that were heavily shaded at the time. While shade can often be a factor, it seemed to be even more important than usual on that day, again probably because of the water clarity.

So, if you get a chance, now would be a good time to try fishing the lease. Bring a few extra flies, to account for the offerings you will likely leave in the willows and cottonwoods along the banks on the upper portion of the lease.

Body: olive dubbing with brown hackle, palmered


Rib: fine gold wire

MVFF Board Meeting Minutes

Monday, October 17, 2016 Submitted by Jim Sorenson, Acting Secretary

The MVFF Board meeting was called to order at 5:30pm in the NMDGF Conference Room by President David Carmichael. In attendance were David Carmichael, Jim Sorenson, Gary Mann, Chuck Mueller and Dennis Lanpher and non-Board members Tom Wobbe, Jim Hulsey, Tom Lightfoot and Ron Bellerose.

- 1. The Minutes of the September 2016 Board meeting were approved as published in the newsletter.
- 2. Gary Mann reported that the Club has a balance of \$12,995. The Treasurer's Report was accepted.
- 3. The Club has 361 members.
- 4. March 25, 2017 was approved as the date for the Kids' Fishing Clinic.
- 5. Ron Bellerose reported on the PHW activities. Because of budget cuts, the Resiliency Program at Ft. Bliss has eliminated all travel. Accordingly, the fly tying and casting for October 26 and the trip to the Lease on November 2 have been cancelled. PHW will hold a fund raiser at Sportsman's Warehouse on November 12.
- 6. Jim Sorenson reported on the meeting of representatives of the Gila/Rio Grande Chapter of Trout Unlimited, the New Mexico Environment Department and the Bureau of Land Management to discuss stream improvements on the Rio Bonito southeast of Lincoln, NM. The BLM will proceed to hire an engineering firm to develop a plan which it will circulate for comment. Overall, it

- looks promising for developing another trout fishing area in southern New Mexico.
- 7. Jill Wick, NMDGF trout biologist, has agreed to discuss the status of Gila Trout recovery and fishing opportunities at the November Club meeting. David will ask Bob Silver to make a presentation regarding the Club trip to Kodiak at the December meeting.
- 8. Saturday, January 28, 2017 was approved as the date for the Club's Annual Banquet. A budget of \$2,200 was approved for raffle prizes.
- David will contact Christian Valle who wants to do a segment on MVFF for the KRWG Community Connection Program.
- 10. The Board will nominate new members to serve on the 2017 Board at its November meeting. Those nominees and any nominations from the floor will be voted on at the December General meeting.
- 11. Tom Wobbe noted that the Club will assist the Las Cruces Public Schools with a 'Special Needs Kids' fishing clinic on November 10, 11 and 12, 2016. Five or six volunteers are needed each day to set up rods and assist any children needing help.

The next Board meeting will be on November 21, 2016 at 7:00pm at The 'Game', as the NMDGF class-room is not available.

Meeting was adjourned at 6:30pm.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575–524–1880), Tom Wobbe (575–522–5437) and Donna Mabie (575–522–3810) in Las Cruces. Permits can be obtained from the land owner, but you should phone (575–687–3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member (current dues have been paid) of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
