Tails: Brown saddle or neck hackle

Body: Black thread spun counterclockwise for

smooth tapered body

Emergent: wing: 3 strands of pearl Krystal Flash or

Flashabou accent

Thorax: Mahogany superfine dubbing



Fishing report from the Rio Peñasco

September 27th 2012 Chuck Mueller

Weather was mostly cloudy with the temperature in the mid 70's to low 80's. The stream was low and clear. There was a nice PMD hatch going when I started fishing. I used a size 14 Copper John and a size 20 Pheasant Tail trailing about 12" behind. I caught a few with that combination but changed over to a PMD emerger and landed a nice 17" rainbow. After the hatch stopped around 10:30am, I switched to an Olive Sculpin and caught 5 more, every one of them over 12 inches. I quit fishing at 2pm when I heard thunder and it started raining. I would say that it was a good day of fishing for the short time I had.









Lady Anglers Fish the Arkansas

Spectacular fall weather greeted five Lady Anglers as they ventured into Colorado to fish the Arkansas River near Salida. Blazing aspens and cool sunny days made for great fishing. Although the river flows had dropped to typical fall levels (260cfs), we got good help

finding fish on our day with guides from Arkanglers. A successful strategy turned out to be dry and dropper, using hoppers and very small midge or mayfly nymphs. With very few exceptions, the strikes were on the nymphs. Also, fishing heavy riffles with a double nymph rig was very successful. Fish liked both the bead-head hare's ear and very small bat-winged emergers. We learned that the fish were feeding in small pockets of slightly calmer water, even in very heavy riffles.

Wading was nearly impossible without wading staffs and landing fish in the heavy water was difficult. A

disappointment was the lack of fall blue winged olives hatching, even when we had cloud cover, making dry fly fishing unproductive. Even when fish could be seen rising, they were taking tiny emergers rather than dries.

Our first day without guides was a learning experience and we found out which strategies do not work. We also found out where fish were NOT feeding. However, after putting our heads together

and talking with other anglers, we came up with a good plan which was very successful for our third and final fishing day. Everyone caught fish, both rainbows and browns. We found that the fish were holding in the heaviest water and were taking the smallest nymphs. We also found a great "secret spot" for fishing next time we are on the Arkansas. Our lips are sealed!

And as always, we had a fantastic time off the water as well. A beautiful spacious rented home with a back deck overlooking the river was our setting. Wonderful dinners and wine at Salida's best restaurants and browsing unique galleries rounded out a really fabulous trip.

We are now busy planning our Lady Angler Spring Getaway. We invite all MVFF women to participate. We would love to hear suggestions from everyone. Be sure to watch for news in the coming months.







MVFF Board Meeting Minutes

The MVFF Board meeting was called to order at 7:00pm in the NMDG&F Conference Room by President Chuck Mueller. In attendance were Chuck Mueller, Ron Warnke, Bob Silver, George Sanders, Jeff Arteburn, Jim Sorenson, Paul Turner and Ron Bellerose and non-Board members, Tom Wobbe, Jim Hulsey and Dick Newton.

- 1. Minutes of the August 2012 Board meeting were approved as published in the newsletter.
- In the Treasurer's absence, Tom Wobbe reported that the Club has a balance of \$14,121 and gave a breakdown of expenses for the past year and permits sold. The Treasurer's Report was accepted.
- 3. The Club has 217 members who have paid their dues for this year.
- 4. Ron Bellerose reported that the Project Healing Waters fly tying and casting clinic for Ft. Bliss soldiers is set for Wednesday, September 19. He is meeting with the American Legion representative this week to determine how many local disabled veterans would be interested in learning more about fly fishing. To accommodate any veterans who are interested in fly tying, Liars and Tyers will be rescheduled to either the fourth Tuesday or Thursday of the month depending upon Tim Mack's availability.
- A motion to provide a permit and gasoline reimbursement up to \$50 from PHW raffle funds for volunteers taking a disabled veteran to the Lease was approved.

- The Club has seven license plates and six hats left. Ron Warnke will place an order for more of each of them.
- Chuck reported that 25 members have signed up for the Club's trip to the San Juan on November 1st to the 4th.
- A motion to reserve \$750 worth of 8" to 10" rainbow trout to be stocked at the Lease on December 1st was approved.
- Speakers for the October, November, December, January and February general meetings have been lined up.
- 10. A motion was passed authorizing the Raffle Prize Committee to order \$1,500 worth of raffle prizes for the annual meeting. The amount will be discussed further at the next meeting when the Treasurer is available.
- 11. Dick Newton made a presentation on the need to have a monitor installed at the Lease to indicate stream flow and clarity to avoid Club members making a wasted trip. He and Jim Hulsey will investigate the feasibility of installing a monitor and having the information linked to the Club's website.
- 12. The request for the Club to provide a fly tying demonstration in October at the Bosque State Park was discussed. In light of the short notice and crowded schedules, we will decline.
- 13. The next Board meeting will be Monday, October 15, 2012 at 7:00pm.

The meeting was adjourned at 9:30pm.

There are several options for the payment of dues. A family is defined as a club member, their spouse and all children 17 years of age or under.



Lease Information

Permits to fish the Club leased waters on the Rio Peñasco can be obtained from Jim Hulsey (575-524-1880), Tom Wobbe (575-522-5437), Donna Mabie (575-522-3810) in Las Cruces and the Sportsman's Elite fly shop (915-587-4867) in El Paso. Permits can be obtained from the land owner, but you should phone (575-687-3362) the night before to ensure someone will be there to sell them to you. Permits can be ordered through the club web page (mvff.org) by filling out the form and mailing as directed. Cost is \$25.00 per day. Kids under 18 fish free but must be accompanied by an adult club member with a permit. You must be a current member of MVFF to fish the lease. Please wear your MVFF identification badge while on the property. New or replacement badges can be obtained by contacting Jim Hulsey. In addition, members can purchase a one-day, one-time permit for out of town guests.

Directions to the Lease:

Follow NM 82 east from Cloudcroft, NM or west from Artesia, NM. The turn off to the lease is located on the right side of the road about 100 yards before mile marker 54 coming from Cloudcroft or 100 yards on the left past mile marker 54 coming from Artesia.
